- 1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites online bids (Through E-tendering portal) from eligible bidders for "Turnkey Construction of a 132kV N.F. Railway Traction Bay at 132kV Silapathar GSS, AEGCL including Supply of Bay Equipment and line bay materials and associated works etc"
- 1.1 Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2 The brief description of scope of Works covered under this Bidding Document is furnished below:
  - Design, Manufacture, Testing at manufacturers works, Supply and Delivery of switchgear
    equipments etc with all fittings and accessories including loading at manufacturer's works,

- 6.6 Clarification Regarding Technical bid:
- 6.6.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard.
- 6.6.2 Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.
- 6.6.3 All clarifications or **shortfall documents shall be submitted through the e-tendering portal only**. No other means of communication shall be considered unless specified by the bidder.

- 7.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal).
