The scope of works shall broadly include the "Rectification of insulation failure of 132kV Narengi Bay at 220/132kV Sonapur GIS, AEGCL. The scope of work includes identification and replacement of faulty barrier, damaged bus duct conductors (if required), replacement of damaged contacts, replenishment of SF6 gas along with necessary onsite testing."

The Chief General Manager (PP&D), AEGCL, now invites eligible firms to indicate their interest in carrying out the works as stated above. Interested parties should provide information demonstrating that they have the required qualifications and relevant experiences to perform the works. The qualifying criteria are:

- A. General Experience: The firm should have carried out and successfully completed contracts in the last 10 years.
- B. Specific Experience: Successful completion of supply, erection, testing and commissioning of GIS bay/equipment of make Jiangsu Jingke Smart Electric Company, China within the last 7 years.
- C. Financial:
  - a) Audited financial statements for the last five financial years.
  - b) Cash Flow statement in prescribed format of ICAI.
  - c) CA certified average annual turnover of the last five years

Expression of Interest shall not be more than 25 pages and must include the following:

- Introductory letter on letter head (with complete contact details – name of the contact person, mailing address, telephone, fax, e-mail etc.)
- Organization profile alongwith all substantiating documents as per requirement of this EoI.
- Documents substantiating the general as well as specific experience as per requirement of this EoI.
- Financial Statements as per requirement
- Proposed methodology, complete technical parameters including specifications and Bill of Quantity(BoQ) depicting estimated budgetary cost.

The interested parties are advised to visit and examine the site where the works are to be carried out and its surroundings, with due permission from AEGCL and obtain for itself on its own responsibility all information that may be necessary for preparing the bid and entering into a contract for the provision of plant and services. The costs of visiting the sites shall be at the party's own expense.

Sealed request for quotations shall be invited from the firms whose proposals meet the technical and qualifying requirements.
