INVITATION FOR BID (IFB)

1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through E-tendering portal) from eligible bidders for

“Turnkey Construction of 01 (one) no. of 33kV OIL Feeder Bay including Civil works at 132kV Moran GSS, AEGCL”

1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.

1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:

- Design, engineering, manufacture, assembly and testing at manufacturer’s works of 33kV terminal equipment and different substation materials.
- Construction of outdoor cable trenches to link the existing cable trenches, kiosk etc. as per drawings and specification.
- Construction of sump pit, boundary wall and approach road as per drawing and specification.
- The price quoted shall include cost of all materials and labour to complete the job in all respect as per drawings and this Section.
- Loading at manufacturer’s works, transportation, delivery and unloading at 132KV Moran Grid substation site.
- Erection, Testing and commissioning of the supplied equipment and structures including construction of foundation and associated civil and electrical works needed for completion of the project and subsequent commissioning of the bay and integration to existing SAS. All the SAS integration works should be carried out in presence of authorized O.E.M representative of existing SAS of Siemens make.
- **The bidders are advised to carefully go through the technical specifications of major items such as Isolator, Circuit Breaker, Current Transformer, Surge Arrester and CRP & SAS of the bidding document before quoting their prices.**
- **Maintenance Free Isolators are proposed in this tender as per the technical specification available in the bid documents, such that equipment requiring minimal maintenance, thereby avoiding unwanted interruptions as requested by Depositor. The bidders are advised to carefully go through the technical specifications. Relevant drawings shall be submitted by the bidder along with the bid in compliance with the technical specifications showing Maintenance free spring less contacts of offered isolators.**

However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee.

4.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 4,000.00** only payable through online mode in assam tenders portal: <https://assamtenders.gov.in>.

5.0 For E-tendering, a ‘**Single Stage Two-Envelope**’ bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

6.0 Qualification of the Bidder

6.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.

6.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

7.0 Submission of Bids

7.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **14:00 Hours on 23/03/2026** and the technical proposals will be opened in the portal at 14:00 Hrs of **24/03/2026**.

7.2 All bids must be accompanied by a tender fee of **INR 4,000.00** and bid security amounting to **INR Rs.3,71,000.00** payable through online mode in assam tender's portal: <https://assamtenders.gov.in>. Bid security shall have to be valid for **30 days beyond the validity of Bid**.

7.3 Scanned copy of the bid security BG in PDF format must be uploaded as part of techno-commercial bid.

7.4 The bidder should submit hard copies of the following documents in a separate physical envelope at least 1(One) hr prior to bid submission deadline. **Techno commercial bids shall not be opened if these documents aren't submitted in hard copy before the aforementioned time and the bid may be rejected.**

a) **Letter of technical Bid.**

b) **Written Confirmation of Authorization to commit the bidder (Notarised power of attorney).**

c) **Notarized JV agreement, if bidder is a JV at the time of submission of the bids. However, the bidder is required to submit registered JV agreement once the contract is awarded to them**

7.5 Bidders are requested to go through the **Checklist** of major documents to be submitted provided in the bid document (Vol – I) and upload the same along with other technical documents.

7.6 AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids

7.7 Clarification Regarding Technical bid:

8.7.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard.

8.7.2 Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.

8.0 Opening of Bids:

8.1 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.

8.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

9.0 SPECIAL NOTE TO BIDDERS:

9.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in> in order to participate in the e-tender.

9.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.

9.3 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through **online mode only** along with all scanned copies of supporting documents (suggested scan at 150 dpi in PDF with a file size up to 10MB). The documents should be duly signed, scanned and uploaded with proper name. However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer authorization of the major items and any other documents if deemed necessary.

9.4 A Bidder will be required to pay a **Non-Refundable Service Fee** (Online only) in order to participate in the bidding process.

9.5 AEGCL will not be responsible for misplacement/delay in receipt of either request for e-bidding OR instrument copy sent by post.

9.6 Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last-minute unforeseen hassle.

10.0 All the corrigendum/addendum will only be published on <https://assamtenders.gov.in>. Bidders are advised to regularly visit the sites for any updates.

11.0 AEGCL is not bound to accept the offer of lowest bidder. The undersigned reserves the right to accept or reject any or all the bids without assigning any reason thereof.
