INVITATION FOR BID (IFB)

1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, (“the Purchaser”) invites **online bids** (Through E-tendering portal) from eligible bidders for

“Turnkey construction of 2(Two) Nos. of 33KV Bays for BVFCL at 220KV GSS, AEGCL, Namrup”

1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.

1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:

- Design, engineering, manufacture, assembly and testing at manufacturer’s works of 33kV terminal equipments and different substation materials.
- Loading at manufacturer’s works, transportation and delivery at respective substation sites as mentioned in the BID, including unloading at destination sites.
- Erection, Testing and commissioning of the supplied equipments and structures including construction of foundation and associated civil and electrical works needed for completion of the project and subsequent commissioning of the bays and integration to existing SAS. All the SAS integration works should be carried out in presence of authorised O.E.M representative of existing SAS.

However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee.

4.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 2,000.00** only payable through online mode in assam tenders portal: <https://assamtenders.gov.in>.

5.0 For E-tendering, a ‘**Single Stage Two-Envelope**’ bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

6.0 Qualification of the Bidder

6.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.

6.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

7.0 Submission of Bids

7.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **14:00 Hours on 22/02/2023** and the technical proposals will be opened in the portal at 14:00 Hrs of **23/02/2023**.

7.2 All bids must be accompanied by a tender fee of **INR 2,000.00** and bid security amounting to **INR Rs.2,94,750.00** in the form of Bank Guarantee or payable through online mode in assam tender's portal: <https://assamtenders.gov.in>. Bid security shall have to be valid for **30 days beyond the validity of Bid**.

7.3 Scanned copy of the bid security BG in PDF format must be uploaded as part of techno-commercial bid. However, the bid security BG in original shall have to be submitted to the office of the Managing Director, before the time specified.

7.4 The bidder should submit hard copies of the following documents in a separate physical envelope at least 1(One) hr prior to bid submission deadline. **Techno commercial bids shall not be opened if these documents aren't submitted in hard copy before the aforementioned time and the bid may be rejected.**

a) **Letter of technical Bid.**

b) **Written Confirmation of Authorization to commit the bidder (Notarised power of attorney).**

c) **Bid Security if not paid via online mode in assam e-tender portal-<https://assamtenders.gov.in>.**

d) **Registered JV agreement, if bidder is a JV.**

7.5 Bidders are requested to go through the **Checklist** of major documents to be submitted provided in the bid document (Vol – I) and upload the same along with other technical documents.

7.6 AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids

7.7 Clarification Regarding Technical bid:

8.7.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard.

8.7.2 Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.

8.7.3 All clarifications or **shortfall documents shall be submitted through the e-tendering portal only**. No other means of communication shall be considered unless specified otherwise.

8.0 Opening of Bids:

8.1 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.

8.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

9.0 SPECIAL NOTE TO BIDDERS:

9.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in> in order to participate in the e-tender.

9.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.

- 9.4 A Bidder will be required to pay a **Non-Refundable Service Fee** (Online only) in order to participate in the bidding process.
- 9.5 AEGCL will not be responsible for misplacement/delay in receipt of either request for e-bidding OR instrument copy sent by post.
- 9.6 Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last-minute unforeseen hassle.
