- **1.0** The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through E-tendering portal) from eligible bidders for "Turnkey Construction of a 132KV Bus Coupler Bay at 132KV GSS, AEGCL, Dhemaji"
- 1.1 Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2 The brief description of scope of Works covered under this Bidding Document is furnished below:
 - Design, Manufacture, testing at manufacturers works, Supply and Delivery of switchgear equipments etc with all fittings and accessories including loading at manufacturer's works, transportation and delivery at respective substation sites, including unloading at destination sites.
 - Erection, Testing & commissioning at site of various equipment and materials including substation steel structures and civil foundation of 1 (one) 132kV Bus Coupler Bay at 132kV GSS, AEGCL, Dhemaji.

Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

6.0 Submission of Bids

- 6.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 31.07 .2023** and the technical proposals will be opened in the portal at **14:00** Hrs of **01.08.2023**
- 6.2 All bids must be accompanied by a tender fee of INR 2,000.00 and a bid security amounting to INR Rs.76,196.00 to be paid via online mode in the Assam e-tender portal- <u>https://assamtenders.gov.in</u>.
- 6.3 Scanned copy of the bid security payment receipt in PDF format must be uploaded as part of technocommercial bid. However, the bid security payment receipt in original shall have to be submitted to the office of the Managing Director, at least 1(one) hour prior to schedule time of bid opening.
- 6.4 The bidder should submit hard copies of the following documents in a separate physical envelope at least 2(two) hrs prior to bid submission deadline. Techno commercial bids shall not be opened if these documents aren't submitted in hard copy before the bid submission deadline and the bid shall be rejected.
 - a) Letter of technical Bid.
 - b) Written Confirmation of Authorization to commit the bidder (Notarised power of attorney).
 - c) Registered JV agreement, if applicable.
- 6.5 AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids

6.6 **Clarification Regarding Technical bid:**

- 6.6.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard.
- 6.6.2 Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.
- 6.6.3 All clarifications or **shortfall documents shall be submitted through the e-tendering portal only**. No other means of communication shall be considered unless specified by the bidder.

7.0 Opening of Bids:

- 7.1 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 7.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

8.0 SPECIAL NOTE TO BIDDERS:

- 8.1 Bidder must create user ID in the web portal <u>https://assamtenders.gov.in</u>. in order to participate in the e-tender.
- 8.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.
- 8.3 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through <u>online mode only</u> along with all scanned copies of supporting documents (suggested scan at 150 dpi in PDF with a file size up to 10MB). The documents should be duly signed, scanned and uploaded with proper name.
