The following modifications may be noted against the aforementioned office Tender notice:

1. **The clause no. 8.2 of the bid shall be read as-**  
"Average Annual Turnover : Minimum average annual turnover **INR 57,000.00** calculated as total certified payments received for contracts in progress or completed, within the last 3 (Three) Years".
2. **The clause no. 8.3 of the bid shall be read as -**  
"Financial Resources: Bidder need to demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet:  
(1) the following cash-flow requirement, **INR 57,000.00** and  
(2) the overall cash flow requirements for this contract and its current works commitment."
3. **The clause no. 9.2 of the bid shall be read as -**  
"Participation as manufacturer, contractor Experience having successfully completed similar works during last 7 years ending last day of the month previous to the one in which applications are invited should be either of the following:  
(a) Three (3) similar completed works costing not less than **76,000.00**.  
(b) Two (2) similar completed works costing not less than **95,000.00**  
(c) One (1) similar completed works costing not less than **1,51,000.00**"

All other terms and condition shall remain the same.


