- 1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:
  - This specification covers the design, manufacturing, testing and supply of ERS suitable for emergency restoration of Double circuit with twin conductor up to the destination stores along with all associated hardware, Polymer insulators, anchors, guy wires, equipments, fittings etc.
    The materials covered under this Specification shall be supplied complete in all respects, including all parts/items/fittings/components required for their efficient performance and satisfactory maintenance under various operating conditions. This shall generally comprise of all required material parts / items/ equipments required for erecting 2 numbers of ERS towers to bypass fallen/damaged 220/132 kV, double circuit transmission towers having twin ACSR/AAAC Moose conductor, AAAC/ACSR Single/twin Zebra, AAAC/ACSR Single/twin Deer, AAAC/ACSR Single/twin Panther, HTLS ACCC Casablanca, HTLS ACCC Drake. Such parts/items/fittings/components that are necessary for the satisfactory operation of the system shall be deemed to be within the scope of the contract, whether specifically included or not in the specification or in the contract schedules. The supplier shall not be eligible for any extra charges for such parts/items/fittings/components etc.
  - Supply of a suitable vehicle of TATA or Mahindra make for transportation of 2 No's of complete ERS
    Towers along with all accessories from the store.
  - Approval of the model of vehicle from the purchaser.
  - Registration, Insurance & necessary Permits, Taxes etc. of the Vehicle should be in the scope of the contractor.

- 6.2 All bids must be accompanied by a tender fee of INR 2,000.00 to be paid via online and bid security amounting to INR 6,00,000.00 to be paid via online mode or Bank Guarantee in the e-tendering portal of Govt. Of Assam, https://assamtenders.gov.in.
- 6.3 Scanned copy of the bid security BG in PDF format must be uploaded as part of techno-commercial bid. However, the bid security BG in original shall have to be submitted to the office of the Managing Director, at least 1(one) hour prior to schedule time of bid opening.

Techno commercial bids shall not be opened if these documents aren't submitted in hard copy before the aforementioned time and the bid shall be rejected.
