(a) The **Assam Electricity Grid Corporation Limited (AEGCL)** hereby invites sealed Bids from eligible Bidders following single stage single bid system of bidding for goods/item(s) as detailed below:

(b) Sealed tenders with a validity period of **180 (One hundred and eighty) days** only from the date of opening of tenders are invited from the bidders for the above work and will be available in <https://assamtenders.gov.in> portal on **08th September 2026 at 10:00 Hrs.** for a nonrefundable fee as indicated in the table above. The method of payment will be online in the e-procurement portal. Tender comprise two Parts, namely the **“Technical Part”** and the **“Financial (Price) Part”**, and both parts must be simultaneously submitted online on <https://assamtenders.gov.in> on or before the deadline **12th October 2026 up to 12:00 Hrs.** The bid submission starts from **6th October 2026 at 10:00 hrs.** Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. The electronic bidding system would not allow any late submission of bids. The **“TECHNICAL PART”** of the Bids will be publicly opened online on **13th October 2026 at 14:00 Hrs** in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below at **14:00 hours**, and this could also be viewed by the bidders online. The **“FINANCIAL PART”** shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

(C) Open Competitive Bidding method shall be followed for selection of most preferred bidder for the tendered Items(s) as mentioned above.
