- 1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through E-tendering portal) from eligible bidders for the work-

**"Preparation of Master Plan & Route Survey for Construction of 1 no. 132/33 kV Grid Substation at Missamari along with the associated transmission lines under AEGCL"**

- 1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:
- Preparation of Masterplan and Route Survey for the associated transmission line for Construction of 132/33 kV Missamari Grid Substation under AEGCL
  - The different tasks need to be carried out in the scope of work are as laid out in the attached – Sch 1 - Schedule of Work for Master Plan & Sch 2 - Schedule of Work for Route Survey in Section-2 (Bidding Forms) as well as Section-3, Employer's Requirements.

- 5.0 For E-tendering, a '**Single Stage Two-Envelope**' bidding procedure will be adopted comprising of (1) Techno-commercial bid and (2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

#### 6.0 **Qualification of the Bidder**

- 6.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 6.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

#### 7.0 **Submission of Bids**

- 7.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 30.10.2023** and the technical proposals will be opened in the portal after **15:00 Hours of 01.11.2023**
- 7.2 All bids must be accompanied by the tender fee of **INR 1,000**. A bid security amounting to **INR 29,000/-** which is to be submitted online






