- 1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through E-tendering portal) from eligible bidders for the work-
"Geotechnical Investigation for construction of 1 nos. of 132/33 kV Grid Substation at Missamari under AEGCL"
- 1.1 Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2 The brief description of scope of Works covered under this Bidding Document is furnished below:
 - Conducting soil investigation test necessary to initiate the process of construction of one no. of 132 kV Grid Substation at Missamari under AEGCL.
 - The different tasks need to be carried out in the scope of work are as laid out in the attached – Sch 1 - Schedule of Work in Section-2 (Bidding Forms) as well as Section-3, Employer's Requirements.

- 4.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 500.00** online.
- 5.0 For E-tendering, a '**Single Stage Two-Envelope**' bidding procedure will be adopted comprising of (1) Techno-commercial bid and (2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.
- 6.0 **Qualification of the Bidder**
- 6.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 6.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.
- 7.0 **Submission of Bids**
- 7.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 30.10.2023** and the technical proposals will be opened in the portal after **15:00 Hours of 01.11.2023**
- 7.2 All bids must be accompanied by the tender fee of **INR 500**. A bid security amounting to **INR 6,000 /-** online.
- 7.3 AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids.


