1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, (“the Purchaser”) invites **online bids**(Through E-tendering portal)from eligible bidders for the work-

“Supply and Delivery of 132kV and 33kV Surge Arresters for various Substations in the Upper Assam Region of AEGCL”

1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.

1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:

The work involves design, engineering, manufacture, assembly, inspection, testing at manufacturer's works before dispatch, packing, supply, including insurance during transit, delivery at site subsequent storage and erection & commissioning at site of various equipment and materials including substation steel structures and civil foundations for equipment as specified in Clauses and Sections of the Bid Document.

However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee. The bidders should also note that only the bidders who have submitted tender fee will be invited for participation in pre-bid meeting, if any.]

3.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 500.00** only in form of a Demand Draft/Banker's cheque.

4.0 For E-tendering, a ‘**Single Stage Two-Envelope**’ bidding procedure will be adopted comprising of (1) Techno-commercial bid and (2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

5.0 Qualification of the Bidder

5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.

5.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

6.0 Submission of Bids

6.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 02 . 07 . 2021** and the technical proposals will be opened in the portal after **14:00 Hours of 03 . 07 . 2021**.

6.2 All bids must be accompanied by the tender fee of **INR 500.00**. A bid security amounting to **INR 66,000/-** in the form of Bank Guarantee. Bid security shall have to be valid for **30 days beyond the validity of Bid**.

- 7.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.
- 8.0 **SPECIAL NOTE TO BIDDERS :**
- 8.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in> in order to participate in the e-tender.
- 8.2 The participating bidders should have valid Digital Signature Certificate (DSC) and have to register in the portal <https://assamtenders.gov.in>.
