## **COMPANY PROFILE**

Assam Electricity Grid Corporation Limited, a vibrant growth oriented Public Sector Company registered under 'Company Act, 1956'. It was formed out of restructured Assam State Electricity Board in 2003 and was notified as the State Transmission Utility (STU). Its core business is to efficiently transport electrical power from electrical power bulk heads to the distribution company networks in the state of Assam.

Assam Electricity Grid Corporation Limited has consistently maintained the transmission system availability over 99% which is at par with other National Transmission Utilities.

- 8.1 The Secretarial Audit Firm shall not sub-contract the Secretarial Audit work.
- 8.2 The Secretarial Audit team will work in strict confidence and will ensure that all data, statements and documents and any other informations in respect of the operation of the Company is dealt with in strict confidence and secrecy.
- 8.3 No partner of the Secretarial Audit firm should be related to either Managing Director or any Whole Time Directors or Part Time Directors or any employee of the Company within the meaning of the Companies Act, 2013.
- 8.4 Neither the Secretarial Audit Firm nor its partner(s) nor associates should have any interest in the business of the Company.
