**C. Intent of the Quotation Enquiry**

Sealed Quotations are hereby invited by the undersigned for & on behalf of the Managing Director, AEGCL, Bijulee Bhawan, Patan Bazar, Guwahati-01 **from the empanelled firms/ contractors for O&M Transmission line works under Lower Assam Region, AEGCL** and having sound technical and financial capabilities for the work "Replacement of composite long rod insulator with porcelain insulator string at LILO section to Amingaon GIS of 132KV Amingaon-Kamalpur Circuit-1", as per terms & conditions mentioned below.

**D. Scope of work:**

The scope of work shall cover the following: -

- Replacement of existing composite long rod insulator with porcelain insulator string as per Bill of Quantity (BoQ)
- Supply of porcelain insulator string shall be done by AEGCL
- Arrangements of any permits required for transportation and movement of supplied materials shall be in the scope of the contractor
- Transit insurance and insurance during storage at site till commissioning shall be in the scope of the contractor.
- All works and labour as per Bill of Quantity and bid specification is under the scope of the bidder
- All works required for site preparation will have to be carried out by the contractor at his own expense, whenever directed by the site In-charge.

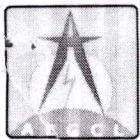


**E. Terms and Conditions:**

1. The total estimated value of the **Rs. 19,95,616.00 (Rupees Nineteen Lakh Ninety-Five Thousand Six Hundred Sixteen)** only which is inclusive of all taxes.
2. **The Price schedule (BoQ) to be collected from the tender inviting authority at O/o The Managing Director, AEGCL, 1st Floor, Bijulee Bhawan, Paltanbazar, Guwahati (Assam)-781001. Rates should be quoted against each item as specified in the BOQ.**
3. **Fund:** AEGCL Own Source
4. **Time of completion:** 90 (Ninety) days from the date of site handover.
5. **Bidders must submit the following documents along with the price bid-**
  - a. Valid electrical license and experience of working on 132kV and above Transmission line towers.
  - b. Valid labour licence
  - c. GST registration certificate
  - d. Up-to-date GST return acknowledgement.
  - e. PAN
  - f. Work order/ performance certificate showing experience in similar nature of work.
6. Payment will be made as per actual measurement of work and will be released subject to availability of fund.
7. **Payment Terms:**
  - a) 100% Payment will be made only after satisfactory completion of the work.
  - b) No advance/Mobilization advance and running bill shall be made for this work. First and final bill shall be released only after final acceptance by AEGCL.
  - c) Bill shall be routed through the respective division offices i.e through the AGM, Kahilipara Division, Kahilipara, Guwahati-19
  - d) Payment will be made subject to availability of fund.
8. **Performance Security:**

Within 15 (fifteen) days of receipt of the notification of award from AEGCL, the contractor shall furnish to AEGCL a performance security in an amount of **10 (ten) percent** of the Contract Price. The form of performance security may be used as acceptable to AEGCL. In case the contractor fails to submit the Performance Security in the form of Bank Guarantee, an amount equivalent to 10% of the Contract Price shall be retained as Security Deposit for upto a period of 12 months. In case an abnormally low bid (ALB) is accepted, then an additional performance security as per the assessment of the tender evaluation committee and not exceeding 20% of the contract value shall be submitted by the successful bidder (vide office order no. MD/AEGCL/Board Agenda/2019/30; dated 30.01.2021).
9. **Bid Price/ Price Basis**
  - a) Bidders shall give a breakdown of the prices in the manner and detail called for in the Schedules of Prices/ BOQ. The quotations will be evaluated for all the items together
  - b) Prices quoted by the Bidder shall be inclusive of all scope of work as specified in this bidding document including Freight and Insurance charges and any related services that is implicit to carry out the work successfully.
  - c) Price will be firm and no price variation will be allowed within the completion period given in the work order. Duties and Taxes shall be adjusted, except there is variation due to changes in legislation of the Country.
10. **Validity of Bid:**

Bids shall remain valid for the period of **180 days** after the bid submission deadline date prescribed by AEGCL. In exceptional circumstances, prior to the expiration of the bid validity period, AEGCL may request the bidders to extend the period of validity of their bids. The requests and the responses shall be made in writing.
