- **1.0** The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through e-tendering portal) from eligible bidders for
 - "Implementation of Fibre Optic Terminal Equipment for Connectivity of Upcoming GSS namely 220KV Chaygaon, 220KV Nagaon, 220KV Khumtai, 220KV Agomoni and its connected PGCIL GSS at remote End."
- 1.1. Bidders shall be required to bid for the complete package and no part offer shall be accepted.
- 1.2. The brief description of scope of works covered under this Bidding Document is furnished below:
 - Design, Engineering, Manufacture, Assembly, Inspection, Testing at Manufacturer's Works before Dispatch, Packing, Supply, Delivery at Site, Including Insurance During Transit, Subsequent Storage, Implementation of Fibre Optic Terminal Equipment for Connectivity of Upcoming GSS namely 220KV Chaygaon, 220KV Nagaon, 220KV Khumtai, 220KV Agomoni and its connected PGCIL GSS at remote End

- 4.0 For e-tendering, a 'Single Stage Two-Envelope' bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal https://assamtenders.gov.in. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.
- 5.0 Qualification of the Bidder
- 5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 5.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.
