INVITATION FOR BID (IFB)

- The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites online bids (Through e-1.0 tendering portal) from eligible bidders for
 - "Turnkey Construction of one no. of 33kV Feeder Bay including Civil Works at 132 KV Nathkuchi GSS, AEGCL for providing power to Pepsico"
- 1.1. Bidders shall be required to bid for the complete package and no part offer shall be accepted.
- The brief description of scope of works covered under this Bidding Document is furnished below:
 - Design, engineering, manufacture, assembly and testing at manufacturer's works of 33kV terminal equipment and different substation materials as per BoQ
 - Construction of outdoor cable trenches to link the existing cable trenches, kiosk etc. as per BoQ and specification.
 - The price quoted shall include cost of all materials and labour to complete the job in all respect as per drawings and this Section.
 - Loading at manufacturer's works, transportation and delivery at respective substation sites, including unloading at destination sites.
 - Erection, Testing and commissioning of the supplied equipment and structures including construction of foundation and associated civil and electrical works needed for completion of the project and subsequent commissioning of the bay and integration to existing SAS. It may be mentioned here that the integration of the newly supplied CRP to the existing Siemens make SAS at 132kV Nathuchi GSS, AEGCL will be in the scope of the contractor. The arrangement for the integration of the C&R Panel with the existing SAS of AEGCL, as desired, shall be under the contractor's scope.
 - Any upgradation of hardware and software for above integration shall be in the scope of contractor including license upgradation (if any). The validity of the license upgraded should be minimum for 10years.

substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

Qualification of the Bidder 5.0

- To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, 5.1 financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to 5.2 know these criteria.

Submission of Bids 6.0

- All bids must be submitted in accordance with the instructions to the Bidders on or before 12:00 Hrs of 01.08.2025 6.1 and the technical proposals will be opened in the portal at 14:00 Hrs on 02.08.2025.
- All bids must be accompanied by a tender fee of INR 1,000.00 and a bid security amounting to INR 3,13,000.00 to 6.2 be paid via online mode in the Assam e-tender portal- https://assamtenders.gov.in/BG.
- Scanned copy of the bid security payment receipt/ EMD BG in PDF format must be uploaded as part of techno-6.3 commercial bid. However, the bid security payment receipt/ EMD BG in original shall have to be submitted to the O/o the MD, AEGCL, at least 2 (two) hours prior to the bid submission deadline along with other hardcopies as specified in Vol-I of the bid.
- The bidder should submit hard copies of the following documents in a separate physical envelope at least 2 (two) 6.4 hours prior to the bid submission deadline. Techno-commercial bids shall not be opened if these documents aren't submitted in hard copy before the bid submission deadline and the bid shall be rejected:
 - a) Letter of technical Bid
 - b) Written Confirmation of Authorization to commit the bidder (Notarised power of attorney)
 - c) Bid Security payment receipt/ EMD BG
 - d) Tender Fee payment receipt
 - e) Registered JV agreement, if applicable
- AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids. 6.5
- Clarification Regarding Technical bid:
- 6.6.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard:
 - a) Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.
 - b) All clarifications or shortfall documents shall be submitted through the e-tendering portal only. No other means of communication shall be considered unless specified by the bidder.

Opening of Bids: 7.0

- AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no 7.1 liability whatsoever consequent upon such a decision.
- Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the 7.2 Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

SPECIAL NOTE TO BIDDERS: 8.0

- Bidder must create user ID in the web portal https://assamtenders.gov.in. in order to participate in the e-tender. 8.1
- A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or 8.2 higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.
- A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must 8.3 be submitted through online mode only along with all scanned copies of supporting documents (suggested scan at 150 dpi in PDF with a file size up to 10MB). The documents should be duly signed, scanned and uploaded
