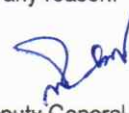

C. Intent of the Quotation Enquiry

Sealed Quotations are hereby invited by the undersigned for & on behalf of the Managing Director, AEGCL, Bijulee Bhawan, Patan Bazar, Guwahati-01 from the empanelled firms/ contractors for civil works under AEGCL for the work "**Construction of Lavatory for Control Room at 132KV Hajo GSS, AEGCL**", as per terms & conditions mentioned below.

D. Terms and Conditions:

- The **scope of work** is as specified in the BOQ and as per instruction of the Site Engineer. All works required for site preparation will have to be carried out by the contractor at his own expense, whenever directed by the site In-charge.
- The total estimated value of the work is **Rs. 2,70,434.00 (Rupees Two lakh Seventy Thousand Four Hundred and Thirty Four) only** which is inclusive of all taxes and the BOQ is as appended herewith. Rates should be quoted against each item as specified in the BOQ.
- Fund:** O&M HQ LAR Fund for the FY 2026-27.
- Time of completion :- 60(sixty) days** from the date of site handover.
- Bidders must submit the following documents along with the price quotation-**
 - Valid labour licence.
 - GST registration certificate.
 - Up-to-date GST return acknowledgement.
 - Work order/ performance certificate showing experience in similar nature of work under AEGCL.
 - Copy of agreement for empanelment under any Circle in AEGCL.
- Payment will be made as per actual measurement of work and will be released subject to availability of fund.
- No advance/Mobilization advance and running bill shall be made for this work. First and final bill shall be released only after final acceptance by AEGCL.
- 10% of the total billed amount will be retained from the bill as **Performance Guarantee (Security Deposit)** and the amount will be released on successful completion of warranty period of **12 (Twelve) months. Liquidated Damages @ 1% (One Percent)** of the amount will be deducted per week subject to a maximum of **10%** of the work value if the time taken to complete the work exceeds the allotted completion time. In case an abnormally low bid (ALB) is accepted, then an additional performance security as per the assessment of the tender evaluation committee and not exceeding 20% of the contract value shall be submitted by the successful bidder (vide office order no. MD/AEGCL/Board Agenda/2019/30; dated 30.01.2021).
- AEGCL reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. The decision of the AEGCL will be final in this regard.
