INVITATION FOR BID (IFB)

1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through E-tendering portal) from eligible bidders for "**Revival of 220KV Samaguri-Mariani Circuit I from Loc. No. 203 to Loc. No. 545**"

1.1 Bidders shall be required to bid for the complete Package and no part offer shall be accepted.

1.2 The brief description of scope of Works covered under this Bidding Document is furnished below:

- (a) Supply of Tower superstructure including nuts and bolts, stubs, ACSR panther conductors as per Bill of Quantity and bid specification.
- (b) Supply of insulators, conductor accessories, hangers, vibration dampers, clamps & connectors, and hardware fittings etc as per BoQ and bid specification.
- (c) Construction of foundation as per BoQ and bid specification.
- (d) Dismantling of existing TL Towers and Erection of new towers, hoisting of insulators, conductor accessories, hardware, clamps and connectors, OPGW etc. including installation of danger plates etc. as per BoQ and bid specification.
- (e) Lowering of existing line conductors and stringing of new conductor as per the BOQ. ERS shall be utilized in the period from lowering of conductor and till charging of the transmission lines. Arrangement of ERS and erection & dismantling of ERS towers shall be in the scope of the Contractor. The contractor shall be responsible for all works related to stringing and lowering of conductor on ERS towers. The ERS will be provided by AEGCL if requested subject to availability and all the expenditure for the same will be borne by the contractor.
- (f) Storage of dismantled Tower structures and TL materials and accessories to AEGCL store including transportation to store and material handling.
- (g) Freight and Transit Insurance, storage at site and site insurance of all material at site shall be in the scope of the contractor.
- (h) Any permits required for supply of materials shall be arranged by the contractor. However, AEGCL shall assist the contractor in arranging permits if any to the extent possible.
- (i) Arrangement of ROW clearances / permission and payment of associated compensation within the corridor of the line will be in the scope of AEGCL. However, the contractor shall provide all necessary assistance for obtaining such clearances / permission.
- (j) Cutting and clearing of trees and bamboos etc. inside / along the corridor of the line shall be in the scope of the contractor.
- (k) ROW outside the corridor of the line shall be in the scope of the contractor. Clearing of trees, bamboo building of temporary roads etc. necessary for execution of the works shall be in the scope of contractor.

However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee.

3.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 20,000.00 only via online mode in the e-tendering portal, <https://assamtenders.gov.in>.**

4.0 For E-tendering, a ‘**Single Stage Two-Envelope**’ bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

5.0 Qualification of the Bidder

5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in the Bidding Document.

5.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

6.0 Submission of Bids

6.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 06/04/2026** and the technical proposals will be opened in the portal at **14:00 Hrs of 07/04/2026**

6.2 All bids must be accompanied by a tender fee of **INR 10,000.00** and bid security/EMD amounting to **INR Rs.71,00,000.00** in the form of Bank Guarantee or payable through online mode in assam tender’s portal: <https://assamtenders.gov.in>. Bid security in the form of Bank Guarantee shall have to be valid for **30 days beyond the validity of Bid.**

6.3 Scanned copy of the bid security payment receipt in PDF format must be uploaded as part of techno-commercial bid. However, the bid security payment receipt in original shall have to be submitted to the office of the Managing Director, at least 1(one) hour prior to schedule time of bid opening.

6.4 The bidder should submit hard copies of the following documents in a separate physical envelope at least 2(two) hrs prior to bid submission deadline. **Techno commercial bids shall not be opened if these documents aren’t submitted in hard copy before the bid submission deadline and the bid shall be rejected.**

- a) **Letter of technical Bid.**
- b) **Written Confirmation of Authorization to commit the bidder (Notarised power of attorney).**
- c) **Original copy of Bid Security/EMD, if not paid via online mode in assam e-tender portal- <https://assamtenders.gov.in>.**
- d) **Notarized JV agreement, if bidder is a JV. However, the bidder has to submit registered JV agreement once the contract is awarded to them.**

6.5 AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids

- 6.6.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard.
- 6.6.2 Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.
- 6.6.3 All clarifications or **shortfall documents shall be submitted through the e-tendering portal only**. No other means of communication shall be considered unless specified by the bidder.

7.0 Opening of Bids:

- 7.1 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 7.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

8.0 SPECIAL NOTE TO BIDDERS:

- 8.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in> in order to participate in the e-tender.
- 8.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.
- 8.3 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through **online mode only** along with all scanned copies of supporting documents (suggested scan at 150 dpi in PDF with a file size up to 10MB). The documents should be duly signed, scanned and uploaded with proper name. However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer authorization of the major items and any other documents if deemed necessary.
- 8.4 A Bidder will be required to pay a **Non-Refundable Service Fee** (Online only) in order to participate in the bidding process.
- 8.5 Service provider/AEGCL will not be responsible for misplacement/delay in receipt of either request for e-bidding OR instrument copy sent by post.
- 8.6 Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last-minute unforeseen hassle.
- 9.0 All the corrigendum/addendum will only be published on <https://assamtenders.gov.in>. Bidders are advised to regularly visit the sites for any updates.
- 10.0 AEGCL is not bound to accept the offer of lowest bidder. The undersigned reserves the right to accept or reject any or all the bids without assigning any reason thereof.
