INVITATION FOR BID (IFB)

1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through e-tendering portal) from eligible bidders for

"Construction of one 33kV feeder at Kamakhya GIS, AEGCL for power supply to MAP Buildcon"

- i) Bidders shall be required to bid for the complete package and no part offer shall be accepted.
- ii) The brief description of scope of works covered under this Bidding Document is furnished below:
- Survey, Design, engineering, manufacture, assembly and testing at manufacturer's works of 33kV terminal equipment and different substation materials.
 - Construction of outdoor cable trenches to link the existing cable trenches, kiosk etc. as per drawings and specification.
 - Construction of 33KV feeder Bay and all associated civil works as per BoQ and bid specification on turnkey basis.
 - The price quoted shall include cost of all materials and labour to complete the job in all respect as per drawings and this Section.
 - Loading at manufacturer's works, transportation and delivery at respective substation sites, including unloading at destination sites.
 - Erection, Testing and commissioning of the supplied equipment and structures including construction of foundation and associated civil and electrical works needed for completion of the project and subsequent commissioning of the bay and integration to existing Substation Automation System (SAS)
 - Any upgradation of hardware and software for above integration shall be in the scope of contractor including license upgradation (if any). The validity of the license upgraded should be minimum for 10years.

2.0 This Bid Identification No: **AEGCL/MD/Tech-406/O&M(LAR)/MAP Buildcon/33kV Bay/BID (R)**

3.0 **Estimate: ₹ 1,36,59,297.00 (Rupees One Crore thirty-six lakh fifty-nine thousand two hundred and ninety-seven only) (Including taxes)**

[To gain time for preparation of their Bids, intending bidders may also inspect or download the Bidding Document by visiting the website, www.aegcl.co.in or <https://assamtenders.gov.in>.

However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee.

4.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 1,000.00 only via online mode in the e-tendering portal, <https://assamtenders.gov.in>.**

5.0 For e-tendering, a 'Single Stage Two-Envelope' bidding procedure will be adopted comprising of



1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

Completion time: 8 (Eight) months from the date of site handover.

6.0 Qualification of the Bidder

- 6.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 6.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

7.0 Submission of Bids

- 7.1 All bids must be submitted in accordance with the instructions to the Bidders on or before 12:00 Hrs of 06.08.2026 and the technical proposals will be opened in the portal at 14:00 Hrs on 07.08.2026.**

- 7.2 All bids must be accompanied by a tender fee of **INR 1,000.00** and a bid security amounting to **INR 2,74,000.00** to be paid via online mode in the Assam e-tender portal- <https://assamtenders.gov.in/BG> OR through EMD BG. In case of EMD BG, the bidder has to submit the original hardcopy of the EMD BG in a closed envelope addressed to the Bid Inviting Authority (clearly specifying the BID ID) before the bid submission end date.
- 7.3 Scanned copy of the bid security payment receipt/ EMD BG in PDF format must be uploaded as part of techno-commercial bid.
- 7.4 The bidder must submit Site visit Certificate (duly signed by the concerned field officials of AEGCL) or Self-certified Site Photographs in the techno-commercial bid.**

- 7.5 AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids.

7.6 Clarification Regarding Technical bid:

- 6.6.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard:
- Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.
 - All clarifications or **shortfall documents shall be submitted through the e-tendering portal only**. No other means of communication shall be considered unless specified by the bidder.

8.0 Opening of Bids:

- 8.1 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 8.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

9.0 SPECIAL NOTE TO BIDDERS:

- 9.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in> in order to participate in the e-tender.
- 9.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.
- 9.3 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & **Price bid must be submitted through online mode only along with all scanned copies of supporting documents (suggested scan at 150 dpi in PDF with a file size up to 10MB)**. The documents should be duly signed, scanned and uploaded with proper name. However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer Authorization of the major items and any other documents if deemed necessary. **The bidder shall ensure that all documents uploaded on the e-tender portal are clear and legible with good**



scan quality. In case any uploaded document is found to be illegible, such document shall be not be considered during evaluation.

- 9.4 A Bidder will be required to pay a **Non-Refundable Service Fee** (Online only) in order to participate in the bidding process.
- 9.5 Service provider/AEGCL will not be responsible for misplacement/delay in receipt of either request for e-bidding OR instrument copy sent by post.
- 9.6 Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last-minute unforeseen hassle.
- 10.0 All the corrigendum/addendum will only be published on <https://assamtenders.gov.in>. Bidders are advised to regularly visit the sites for any updates.
- 11.0 AEGCL is not bound to accept the offer of lowest bidder. The undersigned reserves the right to accept or reject any or all the bids without assigning any reason thereof.
