The scope of works shall broadly include the Examination of execution and completion of left over works of the project "Construction of 220kV S/C line on D/C Tower from Sonabil GSS to Biswanath Chariali GSS", including the needed dismantling & reconstruction works being executed by the turnkey contractor – M/s N K Power and Infrastructure Pvt. Ltd. under AEGCL.

The Chief General Manager (PP&D), AEGCL, now invites eligible firms to indicate their interest in carrying out the works as stated above. Interested parties should provide information demonstrating that they have the required qualifications and relevant experiences to perform the works. The shortlisting criteria are:

- A. General Experience: The firm should have carried out and successfully completed contracts in the last 10 years.
- B. Specific Experience: "Design, Procurement and complete Construction for a similar type of work" or "Supervision of Design, Procurement and Construction for a similar type of work"
- C. Financial:
 - a) Audited financial statements for the last five financial years.
 - b) Cash Flow statement in prescribed format of ICAI.
 - c) CA certified average annual turnover of the last five years
- D. Key Personnel details as follows:
 - a) Experience of Key Personnel
 - b) Qualification of Key Personnel

Expression of Interest shall not be more than 25 pages and must include the following:

- Introductory letter on letter head (with complete contact details name of the contact person, mailing address, telephone, fax, e-mail etc.)
- Organization profile alongwith all substantiating documents as per requirement of this Eol.

- Documents substantiating the general as well as specific experience as per requirement of this Eol.
- Financial Statements as per requirement
- Proposed methodology, complete technical parameters for examination including specifications and Bill of Quantity(BoQ) depicting estimated cost.

A brief background alongwith a draft scope of work and the evaluation criteria is placed at Annexure-I and Annexure-II for reference of the interested parties.

ANNEXURE – I

The contract for the "Construction of 220 kV D/C Single Circuit Transmission Line on Double Circuit Tower from Sonabil to Biswanath Chariali line on Turnkey Basis under Annual Plan" was awarded to M/s N K Power and Infrastructure Pvt. Ltd. on 15.12.2015.

The scope included a total of 136 nos. of Towers and Total Length of 42.768 kms. Out of this, foundation has been completed for 134 nos. of towers and Tower Erection has been completed for 123 nos. of towers. Stringing has been completed for 23.958 kms out of 42.768 kms.

In the course of progress of the works, two nos. of towers have collapsed due to various factors, following which, the works were kept at halt until further enquiry and recommendation from appropriate authority.

The AEGCL Board of Directors, vide the resolution of the recent meetings have recommended for the works to be carried out by the turnkey contractor, M/s NK Power and Infrastructure Pvt Ltd. with renewed terms and conditions the work is about to be resumed and further recommended that the work may be thoroughly examined by 3rd (third) party at the cost of the contractor. The renewed terms include the following among other terms, there shall be random checking of at least 30% of the total tower foundations or more (if necessary). The contractor shall reconstruct the defective tower foundation(s). All pile foundations in the river beds must be reconstructed.

Note: For reference of the interested parties, the Balance works including the needed dismantling and reconstruction shall **account for approx. 35% of the total works**. However, this quantity is tentative.

The actual scope can be ascertained only after completion of identification and necessary survey works.

- 1. The proposals will be evaluated on both the basis of quality as well as cost in QCBS mode.
- 2. The **Technical Score** (**Ts**) shall be calculated through the following basis of marking system for evaluation of technical proposal:

- 3. The bidders with a minimum Technical Score of 60 and above shall be shortlisted.
- 4. Following this, sealed financial bids shall be invited from the shortlisted firms.
- 5. The financial bids with the lowest amount will be given the **Financial Score** (Fs) of 100. The other financial bids shall be scored as follows:

Fs = (Amount of lowest financial bid / Amount of financial bid) x100

6. The total score shall be obtained by weighing the technical and financial scores and adding them. The weight given to the technical and financial proposals are:

Technical Proposal: 0.6 Financial Proposal: 0.4

i.e. Total Score = $Ts \times 0.6 + Fs \times 0.4$

7. The bidder scoring the highest combined technical and financial score may be invited for negotiation. The aim is to reach an agreement on all points and finalize the draft contract.
