**"Geotechnical Investigation for construction of 2 nos. of Grid Substations at Titabor & Rowta under AEGCL"**

1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.

1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:

- Conducting soil investigation test necessary to initiate the process of construction of the two nos. of Grid Sub-stations at various locations in Assam:

4.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 500.00** only in form of a Demand Draft/Banker's cheque.

5.0 For E-tendering, a '**Single Stage Two-Envelope**' bidding procedure will be adopted comprising of (1) Techno-commercial bid and (2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

**6.0 Qualification of the Bidder**

6.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.

6.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

**7.0 Submission of Bids**

- 8.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.
- 9.0 **SPECIAL NOTE TO BIDDERS:**
- 9.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in> in order to participate in the e-tender.
- 9.2 The participating bidders should have valid Digital Signature Certificate (DSC) and have to register in the portal <https://assamtenders.gov.in>.
- 9.3 For other information regarding bid submission, bidders may refer to the Assam Government e-procurement portal <https://assamtenders.gov.in>.
- 9.4 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through online mode only along with all scanned copy supporting documents.
