INVITATION FOR BID (IFB)

1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through e-tendering portal) from eligible bidders for
"Reconductoring of 132kV Rangia-Nalbari S/C Transmission Line with HTLS conductor and associated works"

- 1.1. Bidders shall be required to bid for the complete package and no part offer shall be accepted.
1.2. The brief description of scope of works covered under this Bidding Document is furnished below:

- Design, manufacture, testing, supply, and delivery of HTLS conductor as per Bill of Quantity and bid specification.
- Design, manufacture, testing, supply, and delivery of 132KV Current Transformers and Isolators as per Bill of Quantity and bid specification.
- Supply of insulators, conductor accessories, vibration dampers, clamps & connectors, and hardware fittings etc suitable with offered HTLS conductor as per BoQ and bid specification
- Survey & profiling of existing line route, lowering of existing ACSR Panther conductor along with accessories, Re-rolling on empty drums and transportation to store as per BoQ.
- Stringing of HTLS conductor along with accessories as per Bill of Quantity and bid specification
- Sag adjustment/correction of existing OPGW of 132kV Rangia-Nalbari Transmission line (as per site condition) shall be in the scope of the contractor.
- Minor Modification in transmission line tower (if required) as per site condition shall be in the scope of the contractor
- Dismantling of existing 132KV Current Transformers and Isolators at 220KV/132KV Rangia GSS and 132KV Nalbari GSS as per BoQ
- Erection, Testing, and commissioning of supplied 132KV Current Transformers and Isolators at 220KV/132KV Rangia GSS and 132KV Nalbari GSS as per Bill of Quantity and bid specification
- Freight and Transit Insurance, storage at site and site insurance of all material at site shall be in the scope of the contractor.
- Any permits required for supply of materials shall be arranged by the contractor
- Arrangement of RoW clearances and payment of compensation (if any) shall be in the scope of the Contractor.

- [To gain time for preparation of their Bids, intending bidders may also inspect or download the Bidding Document by visiting the website, www.aegcl.co.in or <https://assamtenders.gov.in>.
- However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee.
- 3.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 1,000.00 only via online mode in the e-tendering portal, <https://assamtenders.gov.in>.**
- 4.0 For e-tendering, a 'Single Stage Two-Envelope' bidding procedure will be adopted comprising of
1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.
- 5.0 **Qualification of the Bidder**
- 5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 5.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.
- 6.0 **Submission of Bids**
- 6.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hrs of 11.03.2026** and the technical proposals will be opened in the portal at **14:00 Hrs on 12.03.2026**.
- 6.2 All bids must be accompanied by a tender fee of **INR 1,000.00** and a bid security amounting to **₹ 47,00,000.00 (Rupees Forty-Seven Lakh) only**
- 6.3 Scanned copy of the bid security payment receipt/ EMD BG in PDF format must be uploaded as part of techno-commercial bid. However, In case of EMD BG, the bidder has to submit the original hardcopy of the EMD BG in a closed envelope addressed to the Bid Inviting Authority (clearly specifying the BID ID) before the bid submission end date as specified in Vol-I of the bid.
- 6.4 AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids.
- 6.5 **Clarification Regarding Technical bid:**
- 6.6.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard:
- a) Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.
- b) All clarifications or **shortfall documents shall be submitted through the e-tendering portal only**. No other means of communication shall be considered unless specified by the bidder.
- 7.0 **Opening of Bids:**
- 7.1 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 7.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.
- 8.0 **SPECIAL NOTE TO BIDDERS:**
- 8.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in>. in order to participate in the e-tender.
- 8.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.

- 8.3 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through online mode only along with all scanned copies of supporting documents (suggested scan at 150 dpi in PDF with a file size up to 10MB). The documents should be duly signed, scanned and uploaded with proper name. However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer Authorization of the major items and any other documents if deemed necessary.
- 8.4 A Bidder will be required to pay a **Non-Refundable Service Fee** (Online only) in order to participate in the bidding process.
- 8.5 Service provider/AEGCL will not be responsible for misplacement/delay in receipt of either request for e-bidding OR instrument copy sent by post.
- 8.6 Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last-minute unforeseen hassle.
- 9.0 All the corrigendum/addendum will only be published on <https://assamtenders.gov.in>. Bidders are advised to regularly visit the sites for any updates.
- 10.0 AEGCL is not bound to accept the offer of lowest bidder. The undersigned reserves the right to accept or reject any or all the bids without assigning any reason thereof.
