Sub: Self-Undertaking on Statutory Tax Compliance.

Whereas, it has been observed that certain vendors/contractors have either not paid statutory taxes or have failed to pay them regularly. While GST compliance is verified within the FinAssam system, in cases where payments are released through Societies or other project entities, such compliance is not consistently verified. This creates financial and reputational risks for the Government.

In line with the policies of the Government of Assam to ensure transparency, integrity, and compliance with applicable laws, & to prevent loss of Government revenue thereby protecting the interests of the State, it is hereby directed that all bidders/contractors are required to submit a self-undertaking regarding payment of statutory taxes as detailed below:

1. Annexure-A (for New Tender Applicants)

- To be submitted along with the bid/tender submission.
- Confirms that the bidder has cleared all statutory dues up to the date of submission and undertakes to discharge any future liabilities during the contract period.

2. Annexure-B (for Ongoing/Existing Contracts)

- To be submitted by contractors already awarded contracts.
- Confirms that all statutory dues under the contract have been cleared up to the present date and undertakes to bear responsibility for any future liabilities during the remaining contract period.
