- 1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- **1.2.** The brief description of scope of Works covered under this Bidding Document is furnished below:
  - Conducting soil investigation test necessary to initiate the process of construction of the two nos. of Grid Sub-stations in Assam:

The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.
