NOTICE INVITING QUOTATION

For & on behalf of the Managing Director, AEGCL, the Deputy General Manager, Bongaigaon T&T Circle, AEGCL, Dhaligaon invites sealed quotations from empanelled parties/firms for O&M of Transmission Lines in AEGCL having sound technical and financial capabilities for the following works:

A) Basic Details:

C) Scope of work:

The scope of work shall cover the following:

- a) Tension insulator string replacement in all phases of both circuits of 132kV Dhaligaon-Gossaigaon S/C transmission line at Location No. 53, 77, 109, 135, 151, 158, 165, 182 &188 (Total 14 strings).
- b) Photographs of before and after of execution of the works location wise. The photographs shall be submitted with the invoice after completion of the works in full.

D) Terms & Conditions:

1. Submission of Bid:

- a. Two envelope bidding procedure will be adopted. Bidders are to submit two sealed envelopes simultaneously enclosed inside one sealed envelope. One containing the techno-commercial proposal (to enclose documents as mentioned in sub clause 4) to be superscribed as "Techno-commercial Bid (Part-I)" and the other containing the quotation (price proposal) superscribed as "Price Bid (Part-II)". Initially, only the Part-I shall be opened. Part-I proposals submitted by bidders which do not conform to the specified requirement, may be rejected as deficient bids. Only the Part-II (Price Bid) proposals of the technically qualified bidders will be opened.
- b. The bids must be submitted at the office of the undersigned on or before the deadline date. Bids received after the deadline and unsealed shall not be entertained under any circumstances whatsoever.
- Value of work: The total estimated value of the work is ₹1,48,680.00 (Rupees One Lakh Forty-Eight Thousand Six Hundred and Eighty) only which is inclusive of GST @ 18% and the BOQ is as per Annexure-I enclosed.
- Time of completion: The works must be completed in all respect within 30 (Thirty) Days from the date of handing over of the site.

4. Eligibility criteria:

- Copy of PAN, GST Registration certificate as per goods and services tax laws must be submitted. GST updated return acknowledged must also be submitted.
- Copy of valid electrical license and labour license issued by competent authority in the State of Assam or in the State where the bidder's business is registered must be submitted.
- c. Proof of empanelment in AEGCL issued by competent authority must be submitted.

5. Bid Prices:

- Rates should be quoted against each item as specified in the BOQ (Price Schedule).
- b. Rates quoted should be exclusive of GST.
- c. Prices quoted shall be inclusive of all scope of work as specified and any related services that is implicit to carry out the work successfully.
- Prices will be firm and no price variation will be allowed within the completion period.

Payment:

- a. 100% Payment will be made as per actual measurement of work after satisfactory completion of the works in full.
- No advance/mobilisation advance and running bill shall be made for this work.
- First and final bill shall be released only after final acceptance by AEGCL.
- d. Payment will be made subject to availability of fund.
- 7. Warranty Period: The time period of warranty of the items shall mean a minimum period of 12 (Twelve) months from the date of taking over of the site in good and acceptable condition by AEGCL. If during the period of warranty, any defect is found, the supplier shall rectify these defects in design, materials and workmanship that may develop under normal use of the equipment upon written notice from the purchaser who shall indicate in what respects the equipment is faulty. The rectification/free replacement must be carried out within a reasonable time period and at free of cost.

8. Validity of bids:

- a. Bids shall remain valid for a period of 60 days after the bid submission deadline date prescribed by AEGCL. In exceptional circumstances, prior to the expiration of the bid validity period, AEGCL may request the bidders to extend the period of validity of their bids. The requests and the responses shall be made in writing.
- Liquidated damage: If the contractor fails to deliver the services on or before the stipulated time, then a
 penalty at the rate of 1% per week of the total order value shall be levied subject to maximum of 10% of
 the total order value.
- 10. The undersigned on behalf of AEGCL reserves the right to withdraw the NIQ, accept or reject any or all quotations or to split the work among different contractors without assigning any reason thereof and he is not bound to accept the lowest value of the quoted rates.
- 11. Other terms and conditions shall be as per AEGCL's General Conditions of Supply and Erection, 2009.
