1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, (“the Purchaser”) invites **online bids**(Through E-tendering portal)from eligible bidders for the work-

“Route alignment and detailed survey of 4 (Four) nos. of Transmission Lines under AEGCL”

1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.

1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:

- a) Preparation of Route Alignment and Detailed survey report to initiate the process of construction of the 4 nos. of Transmission Lines (as mentioned in the bid document) at various locations in Assam.
- b) The different tasks need to be carried out in the scope of work are as laid out in the Schedule of Work in Section-2 (Bidding Forms) as well as Section-3, Employer's Requirements. which briefly comprises Preparation of Preliminary/Walkover Survey Report, Detailed Survey Report and preparation of BOQ as per approved tower schedule .

However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee. The bidders should also note that only the bidders who have submitted tender fee will be invited for participation in pre-bid meeting, if any.]

3.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 500.00** only in form of a Demand Draft/Banker's cheque.

4.0 For E-tendering, a ‘**Single Stage Two-Envelope**’ bidding procedure will be adopted comprising of (1) Techno-commercial bid and (2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

5.0 Qualification of the Bidder

5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.

5.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

6.0 Submission of Bids

6.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 26. 05 . 21** and the technical proposals will be opened in the portal after **14:00 Hours of 27 . 05 . 21**.

6.2 All bids must be accompanied by the tender fee of **INR 500.00**. A bid security amounting to **INR 45,000/-** in the form of BG/DD. Bid security shall have to be valid for **30 days beyond the validity of Bid**.

The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.
- 8.0 **SPECIAL NOTE TO BIDDERS :**
- 8.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in> in order to participate in the e-tender.
- 8.2 The participating bidders should have valid Digital Signature Certificate (DSC) and have to register in the portal <https://assamtenders.gov.in>.
