Any tender without earnest money in the form mentioned above, shall be rejected outright. The EMD shall be returned to the bidder(s) whose offer is not accepted within one month from the date of LoA (s) to the selected bidder(s). The EMD to the successful bidder shall be released on submission of Performance Bank Guarantee at the time of execution of the agreement. However, if the return of EMD is delayed for any reason, no interest / penalty shall be payable to the bidder. EMD submission is exempted for bidders having MSME Certificate and for exemption MSME certificate to be submitted.	The Earnest money for an amount Rs 21,000.00 (Rupees Twenty One Thousand only) which is approximately 2% (Two Percent) of the estimated value shall be submitted in the form of BG or Demand Draft in favour of the MD, AEGCL and should be valid up to 90 days from the Bid opening date. In case of BG, the same should be from the Scheduled Bank of RBI. Any tender without earnest money in the form mentioned above, shall be rejected outright. The EMD shall be returned to the bidder(s) whose offer is not accepted within one month from the date of LoA (s) to the selected bidder(s). The EMD to the successful bidder shall be released on submission of Performance Bank Guarantee at the time of execution of the agreement. However, if the return of EMD is delayed for any reason, no interest / penalty shall be payable to the bidder. EMD is only exempted for MSME/UDYAM registered firm in case the firm has GST registration in Assam state and for exemption of EMD money, MSME/UDYAM certificate to be produced.

Offered equipment that fails to meet the requirements of the bidding document to the satisfaction of the AEGCL engineers present during demonstration shall not be accepted.
4.	10.1 Technical (i)	Factory test certificate(s)/ report(s) for transformer oil tan delta and resistivity kit is to be submitted along with the supply of the same.
