# **INVITATION FOR BID (IFB)**

1. The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites bids from eligible bidders for

#### "Fabrication and Installation of a new gate at the entrance of SLDC, AEGCL, Kahilipara, Ghy along with some other associated works"

- 1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:
- 1.2.1. Dismantling of the existing gate and demolishing RCC works. Stockpiling at designated locations and disposal of dismantled materials. Fabrication and Installation of a new gate at the entrance with steel reinforcement for RCC work along with paint, electrical works and illumination system etc.
  - 1.3. This Bid Identification Nos. as follows: AEGCL/CGM/SLDC/T-177/23-24/Fabrication & Installation of New Gate/BID
  - 1.4. Estimated Cost: Rs.3,95,932.00 (incl GST)
- 2. Bidders may obtain further information from the office of the Chief General Manager (SLDC), AEGCL, Kahilipara, Guwahati - 781019, Assam [e-mail: cgm.sldc@aegcl.co.in ,; Web site: www.assamsldc.in and www.aegcl.co.in . However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee.
- 3. Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non - refundable tender fee of INR 500.00 only in form of a Demand Draft/Banker's cheque etc.
- 4. For tendering, a 'Single Stage Two-Envelope' bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted in hard copies to the O/o the CHIEF GENERAL MANAGER, SLDC, AEGCL, KAHILIPARA, GUWAHATI-19. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened.

#### 5. Qualification of the Bidder





- **5.1.** To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in the Bidding Document. 5
- 5.2. The interested Bidders are advised to visit the office of the CGM(SLDC) or the web site mentioned above to know these criteria.

# 6. Submission of Bids

- **6.1.** All bids must be submitted in accordance with the instructions to the Bidders on or before 12:00 Hours on 03/10/2023 and the technical proposals will be opened at 12:00 Hrs of 09.10.23.
- **6.2.** All bids must be accompanied by a tender fee of INR 500.00 in the form of DD or Bankers cheque, bid security amounting to INR 11,000.00 in the form of Bank Guarantee. Bid security shall have to be valid for 30 days beyond the validity of Bid. The original copy of the Bid Security must be submitted along with relevant documents in Envelope-1.
- **6.3.** The bidder should submit hard copies of the documents mentioned in Appendix 5 of the bid document compulsorily in Envelope-1 along with the bid document signed by the bidder on all pages
- **6.4.** AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids

# 6.5. Clarification Regarding Technical bid:

- **6.5.1.** To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard.
- **6.5.2.** Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.
- **6.5.3.** All clarifications or shortfall documents shall be submitted in hardcopies to the aforementioned address.

# 7. Opening of Bids:

- **7.1.** AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- **7.2.** Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

### 8. SPECIAL NOTE TO BIDDERS :

- **8.1.** A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted in the form of **hard copies only**.
