<b>4.0</b>	<b>Validity of Bids and Bids Prices:</b>
4.1	Bids shall remain valid for a period of 180 days after the bid submission deadline date prescribed by AEGCL. In exceptional circumstances, prior to the expiration of the bid validity period, AEGCL may request Bidders to extend the period of validity of their bids. The request and the responses shall be made in writing. If a bid security shall also be extended for a corresponding period.
4.2	Bidder may refuse the request without forfeiting its bid security. A Bidder granting the request shall not be required or permitted to modify its bid.
4.3	Bidders shall quote for the entire scope of supply and services on a “single responsibility” basis such that the total bid price covers all the Supplier’s obligations mentioned in or to be reasonably inferred from the bidding document in respect of the design, manufacture, including procurement, delivery, and completion of the entire scope.
4.4	Bidders shall give a breakdown of the prices in the manner and detail called for in the Price Schedules.
<b>5.0</b>	<b>Bid Security:</b>
5.1	All bids must be accompanied by a bid security amounting to <b>Rs. ₹ 13500.00</b> only in the form of Bank Guarantee/Demand Draft from any Nationalized Bank payable at Guwahati in favour of <b>AEGCL, Bijulee Bhawan, Paltanbazar, Guwahati-01.</b>
5.2	If a bid security is specified, any bid not complying then his bid shall be rejected by the Employer as non-responsive.
5.3	The bid security of the successful Bidder shall be returned as promptly as possible once the successful Bidder has signed the Contract and furnished the required performance security.
5.4	The bid security of unsuccessful Bidders shall be returned as promptly as possible upon the successful Bidder’s furnishing of the performance security.
5.5	The bid security may be forfeited:
	a) If a Bidder withdraws its bid during the period of bid validity specified by the Bidder.

	<p>b) if the successful Bidder fails to:</p> <p>(i) sign the Contract with in the specified period.</p>
5.6	The Bid Security of a JV shall be in the name of the JV that submits the bid. If the JV has not been legally constituted at the time of bidding, the Bid Security shall be in the names of all future partners as named in the letter of intent.
5.7	If a bid securing declaration is not executed in accordance with the above, AEGCL will declare the Bidder ineligible to be awarded a contract by the AEGCL for the period of time stated in the Form of Bid Securing Declaration.
<b>6.0</b>	<b>Format and Signing of Bid:</b>
6.1	<p>The Bidder shall prepare one original of the Technical Bid and one original of the Price Bid comprising the Bid and clearly mark it —ORIGINAL – TECHNICAL BID and —ORIGINAL - PRICE BID.</p> <p>In addition, the Bidder shall submit three copies of the bid, in the number specified and clearly mark each of them —COPY. In the event of any discrepancy between the original and the copies, the original shall prevail.</p>
6.2	The original and all copies of the Bid shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Bidder. This authorization shall consist of a written confirmation as specified in the Bid Document and shall be attached to the bid. The name and position held by each person signing the authorization must be typed or printed below the signature. All pages of the bid where entries or amendments have been made shall be signed or initialed by the person signing the bid.
6.3	A bid submitted by a JV shall be signed so as to be legally binding on all partners.
6.4	Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the bid.
<b>7.0</b>	<b>Submission and Opening of Bids:</b>
<b>7.1</b>	<b>Submission, Sealing and Marking of Bids:</b>
7.1.1	<p>Bidders may submit their bids by mail or by hand. When so specified in the Bid Document, bidders shall have the option of submitting their bids electronically. Procedures for submission, sealing and marking are as follows:</p> <p>Bidders submitting bids by mail or by hand shall enclose the original and each copy of the Bid, including alternative bids, if permitted in accordance with above, in separate sealed envelopes, duly marking the envelopes as —ORIGINAL and —COPY. These envelopes containing the original and the copies shall then be enclosed in one single envelope.</p>
7.1.2	<p>The inner and outer envelopes shall:</p> <p>(a) bear the name and address of the Bidder;</p> <p>(b) be addressed to the Bidding Authority.</p> <p>(c) bear the specific identification of this bidding process indicated in the Bid Document</p>
7.1.3	The outer envelopes and the inner envelopes containing the Technical Bid shall bear a warning not to open before the time and date for the opening of Technical Bid.
7.1.4	The inner envelopes containing the Price Bid shall bear a warning not to open until advised by the AEGCL.
7.1.5	If all envelopes are not sealed and marked as required, the Employer will assume no responsibility for the misplacement or premature opening of the bid.
<b>7.2</b>	AEGCL may, at its discretion, extend the deadline for the submission of bids by amending the Bidding Document, in which case all rights and obligations of the AEGCL and Bidders previously subject to the deadline shall thereafter be subject to the deadline as extended.
<b>8.0</b>	<b>Eligible Bidders:</b>
8.1	<p>A Bidder may be a private entity or a government-owned entity or any combination of such entities with the intent to enter into an agreement supported by a letter of intent or under an existing agreement in the form of a joint venture, consortium, or association (JV). In the case of a JV:</p> <p>a) all partners shall be jointly and severally liable, and</p> <p>b) the JV shall nominate a Representative who shall have the authority to conduct all business for and on behalf of any and all the partners of the JV during the bidding process and, in the event the JV is awarded the Contract, during contract execution.</p>
8.2	A Bidder, and all partners constituting the Bidder, shall have Indian nationality. A Bidder shall be deemed to have the nationality of a country if the Bidder is a national or is constituted,

	incorporated, or registered and operates in conformity with the provisions of the laws of Republic of India. This criterion shall also apply to the determination of the nationality of proposed subcontractors or suppliers for any part of the Contract including related services.
8.3	AEGCL considers a <b>conflict of interest</b> to be a situation in which a party has interests that could improperly influence that party's performance of official duties or responsibilities, contractual obligations, or compliance with applicable laws and regulations, and that such conflict of interest may contribute to or constitute a prohibited practice under Anticorruption Policy of Government of India and Government Of Assam. In pursuance Anticorruption Policy's requirement that Employer as well as bidders, suppliers, and contractors observe the highest standard of ethics. AEGCL will take appropriate actions if it determines that a conflict of interest has flawed the integrity of any procurement process.
8.4	A firm that is under a declaration of ineligibility by the AEGCL or any Government Entity or PSU at the date of the deadline for bid submission or thereafter i.e. on or before contract signing date shall be disqualified.
8.5	Bidders shall provide such evidence of their continued eligibility satisfactory to the AEGCL, as the Employer shall reasonably request.
8.6	In case a prequalification process has been conducted prior to the bidding process, this bidding is open only to prequalified Bidders.
<b>9.0</b>	<b>Financial Capability:</b>
9.1	Bidder will require to submit along with the bid the audited balance sheets, IT Return and other legal financial statements acceptable to AEGCL, for the recent year to demonstrate the current soundness of the Bidders financial position and its prospective long term profitability. As a minimum, an Applicant's net worth calculated as the difference between total assets and total liabilities should be positive.
9.2	<b>Average Annual Turnover:</b> Minimum average annual turnover <b>INR 2,02,500.00</b> calculated as total certified payments received for contracts in progress or completed, within the last Year.
9.3	<b>Financial Resources:</b> Bidder need to demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet:  (1) the following cash-flow requirement, <b>INR 2,02,500.00</b> and (2) the overall cash flow requirements for this contract and its current works commitment.
9.4	The bidder must furnish their <b>Bank Solvency Certificate</b> to show the bidder's financial position indicating the amount by concerned authority in necessary format as per their banks.
<b>10.0</b>	<b>Experience:</b>
10.1	Experience on similar nature of works under contracts in the role of manufacturers, contractor, subcontractor, or management contractor for at least the last 5(Five) years prior to the bid submission deadline.
10.2	The Bidder should be a supplier or authorized distributor in government agencies/PSU/Electrical utilities. Documentary Evidence of Experience is to be provided in works of a similar nature (as defined in the scope of this bid) in the last five years. The Contractor/Firm should produce work experience/completion certificate from officer not below the rank of Executive Engineer strictly in the name of the Contractor/Firm of similar supply work relevant to the tendered work, done within last 5 years and should be either of the following: (a) Three (3) similar completed works costing not less than <b>Rs. 2,70,000.00</b> . (b) Two (2) similar completed works costing not less than <b>Rs. 3,37,500.00</b> (c) One (1) similar completed works costing not less than <b>Rs. 5,40,000.00</b>
10.3	The Bidder must have experience of executing work of similar nature previously. The bidder must submit experience and completion certificate for scrutiny by AEGCL. Each of such project/ works should consist of completion certificate as per Clause 9.1.
<b>11.0</b>	<b>Evaluation Criteria:</b>
11.1	Evaluation will be done on the basis of <i>Bid Clause</i> No. <b>8.0</b> , Eligible Bidders, Cl. No. <b>9.0</b> , Financial Capability, Cl. No. <b>10.0</b> , Experience and in accordance with the <b>Annexure II</b> to be duly filled in, signed and submitted by the bidder.
11.2	Price Bid of only <b>Responsive and qualified Techno-Commercial Bidders</b> will be opened.
11.3	<b>Arithmetical Error</b> , if observed while in Price Bid evaluation, same will only be corrected.
11.4	<b>Any post bid correction request will NOT BE ENTERTAINED.</b>
11.5	<b>Price Bid Envelope of the Non-responsive Techno Commercial Bidders will be returned to</b>

	the respective bidders against submission of a written request by the bidder.
11.6	<p>The following methodology will be practiced for identification and treatment of the Abnormally Low Bids (ALB) in this tender process of AEGCL:</p> <p>(i) Absolute Approach is to be considered when there are fewer than five substantially responsive bidders and if the bid price is 20% or more below AEGCL's cost estimate then AEGCL's tender evaluation committee should clarify the Bid price with the bidder to determine whether the Bid is abnormally low.</p> <p>(ii) Relative approach is to be considered when there are at least 5(five) nos. of substantially responsive bids and the lowest bid price is 20% or more below AEGCL's cost estimate. In this approach, first the Average bid price is determined and then by deducting the standard deviation from the Average bid price, potentially ALB may be determined.</p> <p>(iii) In case of an ALB, the tender evaluation committee/appropriate authority of the respective tenders shall undertake the following three stage review process which is as below:</p> <ul style="list-style-type: none"> <li>• To identify ALB as per the steps mentioned in SI no. 10.6.(i) and 10.6.(ii), whichever is applicable.</li> <li>• To seek and analyze the clarifications from the abnormally low Bidder in terms of resource inputs and pricing, including overheads, contingencies and profit margins. In that respect, the committee may refer to guideline of World Bank, AIIB, ADB etc. prescribed for ALB.</li> <li>• To decide whether to accept or reject the bid.</li> <li>• On acceptance of the bid, whether Additional Performance Security is to be imposed on the bidder supplemented by adequate justification.</li> </ul> <p>(iv) In case of acceptance of ALB with Additional Performance Security:</p> <ul style="list-style-type: none"> <li>• If any abnormally low bid is accepted with additional performance security, it is to be noted that the total performance security should not exceed 20% of the total contract value.</li> <li>• The additional performance security shall be treated as part of the original performance security and shall be valid for a period similar to that applicable for defect liability period of the contract.</li> <li>• Non submission of the additional performance security shall constitute sufficient ground for rejection of the bid and similar assessment shall then be initiated for next ranked bidder if that bidder is also identified as ALB.</li> </ul>
<b>12.0</b>	<b>Late Bid:</b>
12.1	Any bid submitted <i>after the due date and time</i> will be rejected without any prejudice.
12.2	AEGCL will not be responsible for any Postal and/or Courier Delay in delivering the bid. The same received after the scheduled closing date and time will be rejected without any prejudice.
12.3	Bidding through EMAIL WILL NOT BE ACCEPTED.
<b>13.0</b>	<b>Clarification:</b>
13.1	A prospective Bidder requiring any clarification of the Bidding Document shall contact the AEGCL in writing at the AEGCL's address indicated in the BDS or raise his enquiries prior to 7 (seven) days of closing of the bid. The Employer will respond to any request for clarification, provided that such request is received no later than seven (7) days prior to the deadline for submission of bids. The AEGCL's response shall be in writing with copies to all Bidders who have acquired the Bidding Document including a description of the inquiry but without identifying its source. Should AEGCL deem it necessary to amend the Bidding Document as a result of a request for clarification, it shall do so.
13.2	The Bidder is advised to visit and examine the site where the work is to be Carried out and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the bid and entering into a contract for the provision of plant and services. The costs of visiting the site shall be at the Bidder's own expense.
13.3	The Bidder and any of its personnel or agents will be granted permission by the Employer to enter upon its premises and lands for the purpose of such visit, but only upon the express condition that the Bidder, its personnel, and agents will release and indemnify the Employer and its personnel and agents from and against all liability in respect thereof, and will be responsible for death or personal injury, loss of or damage to property, and any other loss, damage, costs, and expenses incurred as a result of the inspection.
13.4	The Bidder's designated representative is invited to attend a pre-bid meeting, if provided for in the BDS. The purpose of the meeting will be to clarify issues and to answer questions on any

	matter that may be raised at that stage.
13.5	The Bidder is requested, as far as possible, to submit any questions in writing, to reach the AEGCL not later than one week before the pre-bid meeting if there is provision of Pre Bid Meeting.
13.6	Minutes of the pre-bid meeting, including the text of the questions raised, without Identifying the source, and the responses given, together with any responses prepared after the meeting, will be transmitted promptly to all Bidders who have acquired the Bidding. Any modification to the Bidding Document that may become necessary as a result of the pre-bid meeting shall be made by AEGCL exclusively through the issue of an Addendum but not through the minutes of the pre-bid meeting.
13.7	Non-attendance at the pre-bid meeting will not be a cause for disqualification of a Bidder.
<b>14.0</b>	<b>Amendment of Bidding Document:</b>
14.1	At any time prior to the deadline for submission of bids, the Employer may amend the Bidding Document by issuing addenda.
14.2	Any addendum issued shall be part of the Bidding Document and shall be communicated in writing to all who have obtained the Bidding Document from AEGCL.
14.3	To give prospective Bidders reasonable time in which to take an addendum into account in preparing their bids, AEGCL may, at its discretion, extend the deadline for the submission of bids.
<b>15.0</b>	<b>Preparation of Bids by the Bidders:</b>
15.1	<b>Cost of bidding:</b> The Bidder shall bear all costs associated with the preparation and submission of its Bid, and AEGCL shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
15.2	<b>Language of Bid:</b> The Bid, as well as all correspondence and documents relating to the bid exchanged by the Bidder and AEGCL, shall be written in the English language.
<b>15.3</b>	<b>Bid Prices and Discounts:</b>
15.3.1	Unless otherwise specified in the Bid Document and/or AEGCL's Requirements, bidders shall quote for the entire plant and services on a —single responsibility basis such that the total bid price covers all the Contractor's obligations mentioned in or to be reasonably inferred from the bidding document in respect of the including procurement and subcontracting (if any), delivery, construction, installation and completion of the Work. This includes all requirements under the Contractor's responsibilities for completing the work and where so required by the bidding document, the acquisition of all permits, approvals and licenses, etc.; the operation, maintenance and training services and such other items and services as may be specified in the Bidding Document, all in accordance with the requirements of the General Conditions. Items against which no price is entered by the Bidder will not be paid for by the Employer when executed and shall be deemed to be covered by the prices for other items.
15.3.2	Bidders are required to quote the price for the commercial, contractual and technical obligations outlined in the bidding document. If a Bidder wishes to make a deviation, such deviation shall be listed. The Bidder shall also provide the additional price if any, for withdrawal of the deviation.
15.3.3	Bidders shall give a breakdown of the prices in the manner and detail called for in the Price Schedules. Where no different Price Schedules are included in the Bidding Document, bidders shall present their prices in the following manner: (a) Separate numbered Schedules shall be used for each of the following elements. (b) The total amount from each Schedule shall be summarized in a Grand Summary giving the total bid price(s) to be considered.
15.3.4	The price of the work shall be quoted as the Base Price or EXW Price
15.3.5	Sales Tax, GST and all other taxes (as applicable) payable on the work should be indicated separately. In case of failure to indicate so AEGCL will consider such taxes are included in the Offered Price.
15.3.6	Whenever forest produces like sand, stone, timbers etc are used in the work the contractor have to furnish documentary proof that requisite royalty on such produces has been paid to the concerned Department.
15.3.7	When the work being "work contract" which is one and individual and which involves no separate contract for the sale of materials, the contractor shall have not be entitled to get any VAT and or any other taxes, levies reimbursed from the AEGCL for the supply of the materials.
15.3.8	Taxes like work contract, income tax etc. which need to be deducted at source as per the

	prevailing law of the land, will be deducted at source.
15.3.9	<b>The Prices shall be FIXED and FIRM:</b> The Bided Price should on Fixed Price basis, prices quoted by the Bidder shall be fixed during the Bidder's performance of the contract and not subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.
<b>16.0</b>	<b>Additional Requirements:</b>
16.1	<b>Bidders(s) knowledge from actual personal investigation of the resources of the region or District (S) in which he/they offers the work.</b>
16.2	The Bidder shall furnish copy of their PAN Card. The card must be in the name of firm, in case the bidder is a partnership Firm.
16.3	In case the bidder is a partnership Firm, the work experience, solvency and turn over shall be in the name of partnership Firm only.
16.4	<b>Upto date GST Return, and Annual turnover for last three financial year</b>
16.5	<b>GST registration No.</b>
16.6	<b>Registered Power of attorney, if any.</b>
16.7	<b>I T Return for last three financial year</b>
16.8	<b>Audited Balance Sheet and Profit and Loss Account for last three financial year</b>
16.9	<b>Bank Solvency Certificate</b>

<b>17.0</b>	<b>Negotiation with successful bidder:</b>
17.1	The AEGCL reserve the right to hold negotiations with lowest who should be lowest, valid, eligible and technically acceptable bidder considered for award of contract directly if the rates were not unreasonably high.
<b>18.0</b>	<b>TECHNICAL REQUIREMENTS</b>
18.1	<b>Intent of specification</b>
	This section of the specification deals with the technical information & criteria for " <b>Re-tensioning of conductors to maintain minimum ground clearance of the span between loc no. 98-99 and loc no. 204-205 of the 132kV Samaguri-Sankardevnagar D/C Line</b> ". The Contractor's proposal shall be based on the use of materials complying fully with the requirements specified herein.
<b>19.0</b>	<b>Scope of Work</b>
19.1	The scope of work under this contract consists of : a) Re-stringing of conductor for adjustment of Sag as per instruction. b) Replacement of damaged disc insulator of suspension point per string c) Replacement of damaged disc insulator of tension point per string d) Replacement of vibration dampers e) Opening and lowering of conductor including all hardware fittings as per BoQ and bid specification. The works to be executed shall be as per the items mentioned in the BOQ and as per the directions of the site engineer.
<b>20.0</b>	<b>Contractor to inform himself fully</b>
20.1	The Contractor should ensure that he has examined the General Conditions, qualifying criteria, Specifications and Schedules and has satisfied himself as to all the conditions and circumstances affecting the contract price and fixed his price according to his own views on these matters and acknowledge that no additional allowances except as otherwise provided therein will be levied.
20.2	AEGCL shall not be responsible for any misunderstanding or incorrect information obtained by the Contractor other than information given to the Contractor in writing by AEGCL.
<b>21.0</b>	<b>Conformity with Indian Electricity rules &amp; other local regulations wherever applicable:</b>
21.1	The Contractor shall note that all substation works shall comply with the latest provisions of Indian Electricity Rules and with any other regulations. Local authorities concerned in the administration of the rules and regulation relating to such works shall be consulted, if necessary, in regard to the rules and regulations that may be applicable.
21.2	The materials covered by this specification shall, unless otherwise stated be designed, constructed and tested in accordance with the latest revisions of relevant Indian Standards and shall conform to the regulations of local statutory authorities.
21.3	The Contractor shall also comply with the Minimum Wages Act 1948 and the payment of Wages

	Act (both. Of the Government of India and State of Assam) and the rules made there under in respect of any employee or workman employed or engaged by him or his Sub-Contractor.
21.4	All registration and statutory inspection fees, if any, in respect of his work pursuant to this Contract shall be to the account of the Contractor. However, any registration, statutory inspection fees lawfully payable under the provisions of the statutory laws and its amendments from time to time during erection in respect of the Substation Works, ultimately to be owned by the Employer, shall be to the account of the Employer. Should any such inspection or registration need to be re-arranged due to the fault of the Contractor or his Sub-Contractor, the additional fees to such inspection and/or registration shall be borne by the Contractor.
21.5	In case of any conflict between the standards and this specification, this specification shall govern.
<b>22.0</b>	<b>Employer Supervision</b>
22.1	The scope of the duties of the Employer, pursuant to the contract, will include but not be limited to the following. a) Inspect, accept or reject any material and work under the Contract. b) Issue certificate of acceptance and/or progressive payment and final payment certificate.
<b>23.0</b>	<b>DAMAGE TO PERSON AND PROPERTY: -</b>
23.1	The Contractor shall be responsible for all injury to the work or to workmen, to persons, animals or things and for all damages to the structural and/or decorative part of property which may arise from the operations or neglect of contractor or its employees, against whether such injury or damage arise from carelessness, accident or any other cause whatsoever in any way connected with the carrying out of this Contract. The Contractor shall at his cost effect the insurance necessary and indemnify AEGCL entirely from all responsibility in this respect. The scope of insurance is to include loss or damage to the work and workmen due to carelessness, accident including fire, earthquake, floods, all medical expenses, compensation to be borne in the event of accident etc., damage or loss to the Contract itself till this is made over a complete state. Insurance is compulsory and must be affected from the very initial stage and should cover the entire contract period till handing over of complete works. The Contractor shall also be responsible for anything which may be excluded from damage to any property arising out of incidents, negligence or defective carrying out of this Contract.
