- Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be dropped in "Quotation Box" located at AEGCL, Bijulee Bhawan,Paltan Bazar, Ghy-01 of AEGCL (Incase of Offline) or online refer to webpage www.assamtender.gov.in of NIC.
- 3. Rates must be quoted in **Indian rupees** and as per the format specified taxes extra if any must be written separately.
- 4. Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- 5. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
