D) Terms and Conditions:

1. Submission of BID:


- Two Envelope bidding procedure will be adopted where bidders are required to submit two sealed envelopes simultaneously enclosed inside one sealed envelope.
- One containing the techno-commercial proposal (to enclose documents as mentioned in the sub clause 4) to be superscribed as "Techno-commercial BID (Part-I)" and the other containing the quotation (price proposal) superscribed as "Price BID (Part-II).
- Initially, only the Part-I shall be opened. Part-I proposals submitted by bidders which do not confirm to the specific requirement, may be rejected as deficient bids.
- Part -II (Price BID) proposals of the only technically qualified bidders to be opened.

2. Bidding Address: Interested bidders should submit the Quotations at O/o The Deputy General

Manager, Dibrugarh T&T Circle Niz Kadamoni, Dibrugarh-786001, Assam.

3. The Quotations will be opened on the scheduled date & time in presence of the intending bidders and/ or their representative.
4. Eligibility Criteria:
 - a) Copy of PAN, GST registration as per goods and services tax, AADHAR, Firm Registration certificate, need to submitted along with the quotation.
 - b) Copy of valid electrical licence and labour licence issued by competent authority in the state of Assam or in the state where the bidder's business is registered must be submitted.
 - c) The Contractor should have any experience of working in overhead transmission line of 132KV level or above during the last 7 years.
5. AEGCL reserves the right to accept or reject any quotation without showing any reason thereof.
6. The quotation shall be addressed and submitted to the undersigned within the stipulated time.
7. Warranty:
 - a) The contractor warrants that all goods are new, unused and of the most recent or current models, and they incorporate all recent improvements in design and materials, unless provided otherwise in the contract.
 - b) The term period of warranty shall mean the period of 6 months from the date of work completion.
 - c) The offered products and its components must adhere to the latest relevant IEC, IS standards.
 - d) If during the period of warranty any defect is found, the contractor shall rectify all defects in design, materials and workmanship that may develop under normal use of the equipment upon written notice from the purchaser who shall indicate in what respects the equipment is faulty.
 - e) The rectification/ fee replacement must be carried out within a reasonable time period and at free of cost.
8. Rates quoted should be inclusive of all taxes.
9. AEGCL will reject a proposal for award of contract if it detects that the successful Bidder has been involved in corrupt or fraudulent practices in competing for the contract in question. Even if such thing is detected after award of contract, the contract will be cancelled forthwith without any notice.
10. Security Deposit of 10% of the total value is to be deducted from the bill, which will be refunded on successful completion of the warranty period.
11. All other terms & conditions which are not mentioned here will conform to "AEGCL General Terms & Conditions of Supply & Erection 2009.
