1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through E-tendering portal) from eligible bidders for

"Supply and Installation of AC for Scada Room, Control Room and Open Console Room at SLDC, AEGCL including associated works"

- 1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:
 - a) Supply & installation of both indoor and outdoor units of Industrial grade Air Conditioners (Ductable/Cassette) as specified in the BoQ complete with all fittings and fixtures.
 - b) Supply & Installation of all ducts, pipings, cables etc connecting the indoor and outdoor units including drainage pipes complete with all fittings and fixtures as specified in the BoQ.
 - c) Installation of false ceiling as specified in the BoQ including supply of all materials, clamps, fittings and fixtures etc. Including supply and fixing of ceiling lights and associated wiring.
 - d) Dismantling of existing AC units (both indoor and outdoor units) along with the ducts, piping, cabling etc and storage in an orderly manner at a location specified by SLDC officials within the SLDC campus.
 - e) Dismantling of the existing false ceiling and clearing of the debris/materials from SLDC campus.
 - f) Comprehensive Annual Maintenance for 5 (five) year beyond warranty period for the complete Job

- 5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in the Bidding Document.

6.0 Submission of Bids

- 6.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 18.05.23** and the technical proposals will be opened in the portal at **14:00 Hrs** of **19.05.23**.
- 6.2 All bids must be accompanied by a tender fee of **INR 5,00.00**, bid security amounting to **INR 1,00,000.00** in the form of Bank Guarantee. Bid security shall have to be valid for **30 days beyond the validity of Bid**.
- 6.3 Scanned copy of the bid security BG in PDF format must be uploaded as part of techno-commercial bid. However, the bid security BG in original shall have to be submitted to the office of the Managing Director, at least 1(one) hour prior to schedule time of bid opening.
- 6.4 The bidder should submit hard copies of the following documents in a separate physical envelope at least 2(two) hrs prior to bid submission deadline.
 - a) Covering Letter.
 - b) Written Confirmation of Authorization to commit the bidder (Notarised power of attorney).
 - c) Bid Security.
- 6.5 AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids

6.6 **Clarification Regarding Technical bid:**

- 6.6.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard.
- 6.6.2 Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.
- 6.6.3 All clarifications or **shortfall documents shall be submitted through the e-tendering portal**. No other means of communication shall be considered unless specified otherwise.

7.0 Opening of Bids:

- 7.1 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 7.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

8.0 SPECIAL NOTE TO BIDDERS :

- 8.1 Bidder must create user ID in the web portal <u>https://assamtenders.gov.in</u>. in order to participate in the e-tender.
- 8.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.
- 8.3 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through <u>online mode only</u> along with all scanned copies of supporting documents (suggested scan at 150 dpi in PDF with a file size up to 10MB).
