- 1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.
- 1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:
 - Design, engineering, manufacture, assembly and testing at manufacturer's works of 33kV terminal equipments and different substation materials.
 - Loading at manufacturer's works, transportation and delivery at respective substation sites as mentioned in the BID, including unloading at destination sites.

- 7.2 All bids must be accompanied by a tender fee of INR 2,000.00 and bid security amounting to INR Rs.2,33,809.00 in the form of Bank Guarantee or payable through online mode in assam tender's portal: https://assamtenders.gov.in. Bid security shall have to be valid for 30 days beyond the validity of Bid.
- 7.3 Scanned copy of the bid security BG in PDF format must be uploaded as part of techno-commercial bid. However, the bid security BG in original shall have to be submitted to the office of the Managing Director, before the time specified.
- 7.4 The bidder should submit hard copies of the following documents in a separate physical envelope at least 1(One) hr prior to bid submission deadline. Techno commercial bids shall not be opened if these documents aren't submitted in hard copy before the aforementioned time and the bid may be rejected.
