- 1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites online bids(Through etendering portal) from eligible bidders for "Construction of boundary fencing for 40 Bighas of land under AEGCL at 18 Kilo location near 132/33kV Umrangso GSS"
- 1.1. Bidders shall be required to bid for the complete package and no part offer shall be accepted.
- 1.2. The brief description of scope of works covered under this Bidding Document is furnished below:
- 1.3. Construction of boundary fencing for 40 Bighas of land under AEGCL at 18 Kilo location near 132/33kV Umrangso GSS
- 1.4. This Bid Identification Nos. as follows: AEGCL/MD/CGM/CAR/AERC/Umrangso/Part-I/2023/11 Estimated Amount: ₹53,03,426.00 (including GST)

However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee.

- 3.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non refundable processing fee of INR 1070.00 only via online mode in the e-tendering portal, https://assamtenders.gov.in.
- 4.0 For e-tendering, a 'Single Stage Two-Envelope' bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal <a href="https://assamtenders.gov.in">https://assamtenders.gov.in</a>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.
- 5.0 Qualification of the Bidder
- 5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in the Bidding Document.
- 5.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.
- 6.0 Submission of Bids
- All bids must be submitted in accordance with the instructions to the Bidders on or before 13:00 Hrs of 20.03.2024 and the technical proposals will be opened in the portal at 14:00 Hrs on 22.03.2024.
- All bids must be accompanied by a processing fee of INR 1070.00 and a bid security amounting to INR 1,06,069.00 to be paid via online mode in the Assam e-tender portal- <a href="https://assamtenders.gov.in">https://assamtenders.gov.in</a> / BG.
- Scanned copy of the bid security payment receipt in PDF format must be uploaded as part of techno-commercial bid. However, the bid security payment receipt in original shall have to be submitted to the O/o the MD, AEGCL, at least 2 (two) hours prior to the bid submission deadline along with other hardcopies as specified in the bid.
- The bidder should submit hard copies of the following documents in a separate physical envelope at least 2(two) hours prior to the bid submission deadline. Techno-commercial bids shall not be opened if these documents aren't submitted in hard copy before the bid submission deadline and the bid shall be rejected:
  - a) Letter of technical Bid
  - b) Written Confirmation of Authorization to commit the bidder (Notarised power of attorney)

- Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of 7.2 the Bidding Documents shall be considered for opening of Price Bid (price proposal).

- Bidder must create user ID in the web portal <a href="https://assamtenders.gov.in">https://assamtenders.gov.in</a>. in order to participate in the e-tender. 8.1
- A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or 8.2 higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the pertal.
- A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must 8.3 be submitted through online mode only along with all scanned copies of supporting documents (suggested scan at 150 dpi in PDF with a file size upto 10MB). The documents should be duly signed, scanned and uploaded with proper name.
