NOTICE FOR SCRAPPAGE OF VEHICLES

The sealed quotations are to be addressed to the Bidding Address: O/o the DGM, UA T&C and Comm. Circle, AEGCL, Kadamoni, Dibrugarh-786001. The cover should be prominently super scribed with the words “**QUOTATIONS FOR SCRAPPAGE OF DEPARTMENTAL VEHICLES**”. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotation.

Terms & Conditions

1. The Bidder must be a Registered Vehicle Scrapping Facility (RVSF).
2. The Bidder must submit the following documents,
 - a) Valid RVSF registration certificate issued by the Transport Department, Govt. of Assam.
 - b) PAN and GST registration in the name of the RVSF firm.

All documents submitted by the bidders must be duly signed along with seal.

3. Earnest Money Deposit:

- a) The Bidder is required to submit an **Earnest Money Deposit (EMD) of Rs. 1,000.00 (Rupees One Thousand)** only in the form of Demand Draft from a Nationalized Bank or Scheduled Bank of RBI drawn in favour of the “AEGCL, Bijulee Bhawan, Paltanbazar, Guwahati-01” payable at Guwahati. Quotations received without original copy of EMD will not be considered and shall not be accepted.
- b) EMD of the unsuccessful Bidder shall be returned once the Sale order is issued in favour of the successful Bidder.
- c) EMD of the successful Bidder will be returned upon completion of the contract.

4. Site Visit:

The vehicles are available for inspection at the locations mentioned in “**ANNEXURE-I**” during office hours to obtain, at their own responsibility, all information necessary for submission of Bid. The undersigned shall not be responsible and shall not entertain any complaint in respect of any defect in the vehicles.

5. Bid Price:

- a) The Bidder has to quote price for entire lot of the vehicles in the “**QUOTATION/ PRICE SCHEDULE**”, which shall be higher than or equal to the Gross minimum Scrappage value.



- b) The quotations offering price below the minimum scrappage value shall not be entertained and will be rejected.
- c) TCS is applicable on the total quoted value as per extant rules and regulations.
- d) It is reiterated that Bidders must quote rates for all the vehicles, and non-quoting of any one vehicle will render the bid disqualified.
6. The vehicles shall be handed over to the Bidder offering the highest rate and only after depositing the quoted amount.
7. **Payment:**
- a) The Successful Bidder has to deposit the Bid amount in the form of Demand Draft in favour of the "AEGCL, Bijulee Bhawan, Paltanbazar, Guwahati-01" payable at Guwahati to the undersigned **within 10 (Ten) days of issuance of Sale Order** otherwise his EMD is liable to be forfeited and his bid will be cancelled.
- b) The bid amount is exclusive of GST and other taxes, hence all the taxes shall be paid by the Bidder as per the rates applicable with intimation to this office after which the formal order to lift the said vehicles will be issued by the undersigned.
8. The vehicles to be scrapped shall be taken by the successful bidder at his/her own cost within **15(fifteen) working days** after depositing the bid amount and this office shall not owe any responsibility for transfer of the vehicles.
9. The vehicles will be handed over on "as is where is basis". No enquiry of bidder shall be entertained once the vehicles are handed over.
10. Upon taking delivery of the scrapped vehicle, the Buyer shall submit the Certificate of Deposit to the owner as proof of transfer of the vehicles and thereafter, the Buyer shall be responsible for completion of the scrapping and deregistration process of the vehicles at their own cost.
11. The Buyer will be responsible for future legal matters whatsoever, pertaining to the vehicle after taking delivery.
12. The bidders will not be allowed to withdraw their bids, under any circumstances otherwise their Earnest Money will be forfeited.
13. **Jurisdiction:**
- Any disputes arising out of the contract shall first be discussed and settled bilaterally between AEGCL and concerned party. The disputes, legal matters, court matters, if any arising out of the agreement shall be subject to Jorhat jurisdiction only.
14. The undersigned reserves the right to accept or reject any/ all of the quotations (Party or whole), at any time without assigning any reason thereof. The decision of the Auction committee conducting the auction shall be final and binding on the Bidder(s).
15. Bidders are not entitled to claim any damage or compensation in case of such cancellation.
