The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Lessor") invites "Request for Proposal" from experienced parties ("the Lessee") for the "Leasing of Dark Fibres of OPGW installed in AEGCL's Optical Fibre Network".

 [To gain time for preparation of their Bids, intending bidders may also inspect or download the Bidding Document by visiting the website: www.aegcl.co.in . However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee.
- 2. Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non refundable tender fee of INR Rs. 2000/- (Rupees Two Thousand Only) in the form of Demand Draft (DD) in favor of Assam Electricity Grid Corporation Ltd. (AEGCL) payable at Guwahati (Original documents should be enclosed in Envelope-I).
- 3. For the whole process, a 'Single Stage Two-Envelope' bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted in separate sealed pack envelope i.e.; first envelope must contain techno-commercial documents along with other required documents as mentioned in RFP and the other must contain price / financial documents along with other required documents as mentioned in RFP. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

4. Qualification of the Bidder

To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in the RFP Document.

5. Submission of Bids

- 5.1All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 14.10.2025** and the technical proposals will be opened at **15:00 Hrs of 15.10.2025**.
- 5.2All bids must be accompanied by a tender fee of **INR 2,000.00 and a** bid security "**Earnest Money Deposit**" (EMD) amounting to Rs. 15,00,000.00 (Rupees Fifteen Lakhs) only. EMD should be submitted in the form of Bank Guarantee or Demand Draft in favour of MD, AEGCL and should be valid up to 180 (One Hundred and Eighty) days from the bid opening date. In case of BG the same should be from schedule bank of RBI. Exemption is allowed for MSME who are registered with NSIC. For claiming exemption tenderers registered NSIC should enclose the latest NSIC registration certificate duly signature with stamped (**Original documents should be enclosed in Envelope-I).** EMD shall be released i) For unsuccessful bidder after award of work to the successful bidder ii) For successful bidder after award of work, submission of Performance BG and submission of advance yearly payment.
- 5.3 **Validity of bid:** Bid submitted should be valid for a period of 180 days from opening date of tender.
- 5.4The bidder should submit hard copies of the following documents in a separate physical envelope at least 2(two) hrs. prior to bid submission deadline. (Bids submitted after the bid submission deadline shall be rejected.)
