1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, (“the Purchaser”) invites **online bids** (Through e-tendering portal) from eligible bidders for the work-

“Procurement of Spare equipment for 132/33 AIIMS GSS, AEGCL at Changsari, Guwahati”

1.1 Bidders shall be required to bid for the complete Package and no part offer shall be accepted.

5.0 For E-tendering, a ‘**Single Stage Two-Envelope**’ bidding procedure will be adopted comprising of (1) Techno-commercial bid and (2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

6.0 Qualification of the Bidder

6.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.

9.2 The participating bidders should have valid Digital Signature Certificate (DSC) and have to register in the portal <https://assamtenders.gov.in>.

9.4 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through **online mode only** along with all scanned copy of supporting documents.
