## Invitation for Bid (IFB)

1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites **online bids** (Through E-tendering portal) from eligible bidders for the work-

**"Turnkey Construction of 1 (one) no. of 132/33kV, 50MVA Transformer Bay (both LV & HV) along with related services at 132kV Srikona GSS of AEGCL".**

1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.

1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:

- Design, engineering, manufacture, assembly and testing at manufacturer's works of 33kV & 132kV terminal equipment and different substation materials.
- Construction of outdoor cable trenches to link the existing cable trenches, kiosk etc. as per drawings and specification.
- Construction of transformer pad and fire protection wall as per drawing and specification.
- The price quoted shall include cost of all materials and labour to complete the job in all respect as per drawings and this Section.
- Loading at manufacturer's works, transportation and delivery at respective substation sites, including unloading at destination sites.
- Erection, Testing and commissioning of the supplied equipment and structures including construction of foundation, pile foundation and associated civil and electrical works needed for completion of the project and subsequent commissioning of the bay and integration to existing SAS. All the SAS integration works should be carried out in presence of authorised O.E.M representative of existing SAS of Siemens make.
- Any upgradation of hardware and software for above integration shall be in the scope of contractor including license upgradation (if any) if specified in the Price Schedule or BoQ. The validity of the license upgraded should be minimum for 10years.
- Augmentation of the existing bus conductor system with Twin ACSR Zebra Conductors, including dismantling (where required), supply of all accessories, erection, stringing, tensioning, jumper connections, clamps, connectors, spacers and associated hardware, complete in all respects as specified in the BoQ, Technical Specifications and approved drawings.
- The Contractor shall provide all materials, consumables, construction equipment, tools and tackles, temporary works, skilled and unskilled manpower, supervision, quality assurance, testing facilities and all incidental items not specifically mentioned but necessary for the complete, safe and reliable execution, testing, commissioning and successful operation of the project. Any item or activity essential for satisfactory completion of the works shall be deemed to be included in the Contractor's scope, irrespective of whether specifically mentioned in the Bidding Documents.

- 2 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 1000.00** only in online mode in the Assam e-tender portal- <https://assamtenders.gov.in>.

- 3 For E-tendering, a '**Single Stage Two-Envelope**' bidding procedure will be adopted comprising of (1) Techno-commercial bid and (2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. However, the bidder must submit hard copies of the documents along with the techno-commercial bid as specified in point no. 5.4. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements of the Bidding Document shall be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document, shall be opened on a future date which shall be notified in due course of time.

#### 4 Qualification of the Bidder

- 4.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 4.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

#### 5 Submission of Bids

- 5.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 19.08.2026** and the technical proposals will be opened in the portal after **14:00 Hours of 20.08.2026**.
- 5.2 All bids must be accompanied by the tender fee of **INR 1,000.00**. A bid security amounting to **INR 6,00,000.00/-** in the form of Bank Guarantee or via online mode in the Assam e-tender portal- <https://assamtenders.gov.in>. Bid security shall have to be valid for **30 days beyond the validity of Bid**.
- 5.3 Scanned copy of the bid security BG in PDF format must be uploaded as part of techno-commercial bid. However, the bid security BG payment in original shall have to be submitted to the office of the Managing Director, prior to schedule time of bid opening.
- 5.4 The bidder should submit the hard copies of the following documents in a separate physical envelope prior to bid submission deadline. Techno-commercial bids shall not be opened if these documents aren't submitted in hard copy before the bid submission deadline and the bid may be rejected.
- a) Letter of Technical Bid;
  - b) Written confirmation of authorization to commit the Bidder (i.e., Notarized Power of Attorney)
  - c) Bid Security, if not paid via online mode in assam e-tender portal-<https://assamtenders.gov.in>
  - d) Notarized/Registered JV agreement, if applicable.
- 5.5 AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids.

#### 6 Clarification Regarding Technical bid:

- 6.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for clarification of its bid or to resubmit any shortfall documents. However, the following may be noted in this regard.
- 6.2 Any clarification submitted by a Bidder that is not in response to a request by the Purchaser shall not be considered.

- 7.1 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 7.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

## 8 SPECIAL NOTE TO BIDDERS:

- 8.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in> in order to participate in the e-tender.
- 8.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal <https://assamtenders.gov.in>.
- 8.3 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through **online mode** along with all scanned copy supporting documents (suggested scan at 150 dpi in PDF with a file size up to 10MB). The documents should be duly signed, scanned and **uploaded with meaningful name**. However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer authorization of the major items and any other documents if deemed necessary.
- 8.4 A Bidder will be required to pay a Non-Refundable Service Fee (Online only) in order to participate in the bidding process.
- 8.5 Service provider/AEGCL will not be responsible for misplacement/delay in receipt of either request for e-bidding OR instrument copy sent by post.
- 8.6 Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last minute unforeseen hassle.
